No.211/Exam Dated.02.04.2025 indicates that Combined Defence Services (CDS) Examination-I, 2025 & National Defence Academy (NDA) and Naval Academy (NA) Examination-I, 2025 will be held on 13.04.2025 (Sunday) from 09:00 hrs to 18:00 hrs being conducted by the Union Public Service Commission, New Delhi. A total number of candidates 2566 (Two Thousand Sixty Six) are supposed to appear in the Examination at 05 (Five) Venues (Siliguri Centre) within the area of Siliguri Police Commissionerate;

WHEREAS, there is apprehension of breach of peace and tranquillity on the day of examination in the vicinity of the examination venues;

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquillity on the aforesaid day in and around the examination venue;

than examinees, invigilator, support staff and such other person related to the said examination shall not assemble

in the compound/ premises/ around the venue of said examination; and

- 2. Prohibit assembly of **five (5) or more persons** within the radius of 100 (one hundred) meters of the periphery of the examination venue within the Metropolitan area of Siliguri;

Whereas, information has been received from reliable sources that smuggling and infiltration within 8 kms of Indo-Bangladesh International Border under Siliguri Police Commissionerate are causing / likely to cause grave danger to human life, property and public and a speedy remedy is necessary.

Now therefore, in exercise of the power conferred by Sub-section (1)(2) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 (2 of 2023) I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit movement of food grains and foodstuff i.e. rice, paddy, sugar, salt, wheat, pulses and other essential commodities and movement of trucks carrying cattle, livestock etc from 7-00 P.M each day to 6-00 AM next morning daily within 8 kms of Indo-Bangladesh International Border areas under Siliguri Police Commissionerate. In addition to this, grazing of cattle at night within 300 (Three hundred) meters of Indo-Bangladesh International Border is also prohibited from 7-00 PM each day to 6-00 AM next morning.

This order will take immediate effect and will remain in force from 30th March 2025 to 28th May 2025.

Whereas, information has been received from credible sources that violent demonstrations are likely to take place resulting in large scale disturbance of the public tranquillity and breach of the peace in the area mentioned in the schedule below of the NJP PS, under the Siliguri Police Commissionerate.
