Whereas, information has been received from reliable sources that smuggling and infiltration within 8 kms of Indo-Bangladesh International Border under Siliguri Police Commissionerate are causing / likely to cause grave danger to human life, property and public and a speedy remedy is necessary.

Now therefore, in exercise of the power conferred by Sub-section (1)(2) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 (2 of 2023) **I, C. Sudhakar, IPS**, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit movement of food grains and foodstuff i.e. rice, paddy, sugar, salt, wheat, pulses and other essential commodities and movement of trucks carrying cattle, livestock etc from 7-00 P.M each day to 6-00 AM next morning daily within 8 kms of Indo-Bangladesh International Border areas under Siliguri Police Commissionerate. In addition to this, grazing of cattle at night within 300 (Three hundred) meters of Indo-Bangladesh International Border is also prohibited from 7-00 PM each day to 6-00 AM next morning.

This order will take immediate effect and will remain in force from 29th May 2025 to 27th July 2025.

WHEREAS, information received from the Additional Director General & Inspector General of Police, Law and Order, West Bengal vide Memo No. 113 (13)/CR Dated 13.06.2025 arose from No. WBE/CH/026/25-26 Dated 11.06.2025 of the Chairman, WBEEB indicates that West Bengal Joint Entrance Examination Board is going to conduct the Presidency University Bachelor Degree Entrance Test (PUBDET-2025) for admission to Undergraduate Course in Presidency University. This year the examination will be held on **21st & 22nd June, 2025 from 10:00 AM to 11:30 AM, 12:30 PM to 2:00 PM, and 3:00 PM to 4:30 PM in 01 (One) Centre** within the area of Siliguri Police Commissionerate. Total **340 (Three Hundred Forty) Candidates** are supposed to appear in the said Examination within the jurisdiction of SPC;

WHEREAS, there is apprehension of breach of peace and tranquillity on the day of examination in the vicinity of the examination venues;

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination venue;

NOW, THEREFORE, in exercise of the power conferred by sub sec (1) read with sub sec (3) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 (2 of 2023) **I, C. Sudhakar, IPS**, Commissioner of Police, Siliguri and Executive Magistrate in relation to the Metropolitan area of Siliguri and being empowered so to do by the State Govt. do hereby-

1. I in exercise of power conferred upon me U/S- 163 (2) BNSS I do hereby direct that **5 (five) or more person**, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/ premises/ around the venue of said examination; and

2. Prohibit assembly of **five (5) or more persons** within the radius of 100 (one hundred) meters of the periphery of the

examination venue within the Metropolitan area of Siliguri; and

3. Prohibit plying of loud speaker, microphone etc in and around 200 (two hundred) meters of examination venues.
Use of Mobile Phones in an around 200 (two hundred) meters except the invigilators & venue in-charge is strictly prohibited; and

4. I do hereby also prohibit entrance of any person(S) except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till the completion; and

5. Prohibit all the Photo Copying Centres located within 100 meters from the examination venues on the **day (21/06/2025 & 22/06/2025)** of examination from **09:00 hrs till examination process is over.**

6. Exigency of the situation does not allow me to serve the notice to the aggrieved parties, if any, and the order is passed ex-parte u/s 163(2) of BNSS of 2023.

Whereas, I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Notification No. 1548-P.S. Cell/HR/O/3P-42/2014 dtd 16/08/2024 of Senior Deputy Secretary to the Govt. of West Bengal.

Whereas, in my opinion, there is sufficient ground for proceeding under the said section for immediate prevention of disturbances of public tranquillity and breach of peace within the area-in-question of the Siliguri Police Commissionerate.

And

Now therefore, in exercise of the power conferred by Sub-section (1)(3) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit for the period **60 (sixty) days w.e.f 22nd June 2025 to 20th August 2025** until further order, any assembly of 05 (five) or more person in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquillity and breach of the peace within the said area of NJP PS, Siliguri Police Commissionerate.

During the course of performing patrolling duty she went at an open premises of Sri Guru Vidyamandir near Champasari under Pradhannagar PS, SPC and started to misbehave with young boys and girls sitting over there and assaulted few of them under the influence of liquor. On 23.10.2024 at around 21.35 hrs one Mampa Adhikary w/o Joydeb Adhikary of Champasari Anchal, PS-Pradhannagar, Dist-Darjeeling came to Pradhannagar PS along with two medical slips of her daughter Koyel Adhikary (16 yrs) and one Riddhik Biswas who were assaulted by her and made a verbal complaint which was diarised at Pradhannagar PS vide G.D.E No- 1325 date-23.10.2024. The whole incident of hot altercation and misbehaviour was recorded by the local people and made it viral. Her such act showed an aberration the ethics of disciplined department and tarnished the image of Police Department in the eye of common people.

FINAL ORDER PASSED BY SHRI TANMOY SARKAR DY. COMMISSIONER OF POLICE (HQ) SILIGURI POLICE COMMISSIONERATE IN C/W THIS UNIT PROCEEDING NO-07/2024 DATED-03.02.2024 DRAWN UP AGAINST PD 648 PARTHA PRATIM MUKHERJEE OF SILIGURI POLICE COMMISSIONERATE

The charge as drawn up PD 648 Partha Pratim Mukherjee is summarized below:

On 22.11.2000 you PD 648 Partha Pratim Mukherjee married Smt. Jayanti Mukherjee (Biswas) according to Hindu rites and custom and have a female child namely Poushali Mukherjee in the year 2004. From the very beginning of the marriage you were found very dominating in nature. You harass your wife for money from her father and torture her if she refused to asked same. You are having an illicit affair with another woman even though you are married. On 25.06.2019 at around 4.30 p.m you physically assault your wife and also strangulate your daughter. On the basis of the written complaint Matigara PS Case No- 495/2019 Dt-12.07.2019,U/S-498 A IPC, r/w Sec-3/4 of D.P Act IPC was initiated against you.

The charged PD 648 Partha Pratim Mukherjee received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 10.02.2024. In his written reply dated 14.02.2024, he did not plead guilty to the charges drawn up against him and preferred an open enquiry. The Proceedings File

No. 07/2024 dated 03.02.2024 was endorsed to Shri Somnath Das, Assistant Commissioner of Police (East-II), SPC for submission of findings at an early date. On completion of enquiry, Shri Somnath Das, Assistant Commissioner of Police (East-II), SPC submitted his findings on 12.05.2025.

I have carefully gone through the deposition of prosecution witnesses, Defence witness, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as 03 P.Ws, and concerned 06 documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the Charged Officer to defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 12.05.2025 with the opinion that the charge as levelled against Charged PD 648 Partha Pratim Mukherjee has been proved beyond any reasonable doubt.

On 26.06.2025 the Charged PD 648 Partha Pratim Mukherjee was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, pass the Final Order as:- "The pay of the charged PD 648 Partha Pratim Mukherjee is withheld by 01 (one) increment from the next date of his due increment for (01) one year without cumulative effect."

As per Rule 883 of PRB Vol -I the Charged Constable is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.

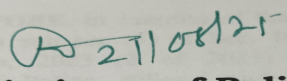
