**Whereas**, information has been received from reliable sources that smuggling and infiltration within 8 kms of Indo-Bangladesh International Border under Siliguri Police Commissionerate are causing / likely to cause grave danger to human life, property and public and a speedy remedy is necessary.

**Now therefore**, in exercise of the power conferred by Sub-section (1)(3) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 (2 of 2023) **I, C. Sudhakar, IPS**, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit movement of food grains and foodstuff i.e. rice, paddy, sugar, salt, wheat, pulses and other essential commodities and movement of trucks carrying cattle, livestock etc from 7-00 P.M each day to 6-00 AM next morning daily within 8 kms of Indo-Bangladesh International Border areas under Siliguri Police Commissionerate. In addition to this, grazing of cattle at night within 300 (Three hundred) meters of Indo-Bangladesh International Border is also prohibited from 7-00 PM each day to 6-00 AM next morning.

This order will take immediate effect and will remain in force from 28<sup>th</sup> July 2025 to 25<sup>th</sup> September 2025.

The charge as drawn up ASI (UB) 440 Ram Prasad Adhikary is summarized below:

On 01.11.2023 at 17.45 hrs a written complaint has been received from one Pranita Adhikary w/o Ram Prasad Adhikary of Debithakurbari, PS- Rajganj, Dist-Jalpaiguri against him [ASI (UB) 440 Ram Prasad Adhikary] of Siliguri Police Commissionerate and one Sanjita Orow D/O- Tulshi Orow of Menghora Gate Bazar, PS- NJP, Dist-Jalpaiguri to the effect that on 09.03.1998 the complainant got registry marriage with him and had two sons from your conjugal married life. He failed to maintain conjugal life with his wife Smt. Pranita Adhikary as she alleged physical torture due to extra martial affair with one Sanjita Orow with whom he was illegally residing at Menghora Gate Bazar, PS- NJP, Dist-Jalpaiguri. He also denied to pay for the household expenses. Over this Rajganj PS Case No- 527/2023 dt-01.11.2023 U/S-498A/494 IPC was initiated against him.

The charged officer ASI (UB) 440 Ram Prasad Adhikary received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 12.02.2024. In his written reply dated 19.02.2024, he did not plead guilty to the charges drawn up against him and preferred an open enquiry. The Proceedings File No. 08/2024 dated 09.02.2024 was endorsed to Shri Moksedur Rahaman, Assistant Commissioner of Police (ICP Fulbari), SPC for submission of findings at an early date. On completion of enquiry, Shri Moksedur Rahaman, Assistant Commissioner of Police (ICP Fulbari), SPC submitted his findings on 01.05.2025.

I have carefully gone through the deposition of prosecution witnesses, Defence witness, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as 04 P.Ws, 03 DWs and concerned 12 documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the Charged Officer to

defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 01.05.2025 with the opinion that the charge as levelled against Charged officer ASI (UB) 440 Ram Prasad Adhikary has been proved beyond any reasonable doubt.

On 16.07.2025 the Charged officer ASI (UB) 440 Ram Prasad Adhikary was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, I pass the Final Order as:-

"The pay of the Charged officer ASI (UB) 440 Ram Prasad Adhikary is reduced by one increment w.e.f-01.08.2025 to 31.07.2026 for one year without cumulative effect."

As per Rule 883 of PRB Vol -I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.

The charge as drawn up against ASI (UB) 314 Barku Mardi is summarized below:-

He [ASI (UB) 314 Barku Mardi of Ashighar OP, SPC] was found unauthorized absent on-05.09.2024 am after completion of Post Promotional Training vide Org No-1455/RO,SPC dt-09.09.2024. In this context warning notice was issued to him at his residential address through O/C Hemtabad PS, Uttar Dinajpur with a direction to join his duty vide this unit Org No- 1459/ RO, SPC Dated-10.09.2024. On 04.10.2024 pm he reported his arrival at Reserve Office, Siliguri Police Commissionerate after being unauthorised absent for 30 days. On 15.10.24 pm he was detailed for L/O duty at Ashighar OP, SPC but he did not turn up for his duty and found unauthorised absent vide Ashighar OP Org No-160/2024 dt-16.10.24. In this context warning notice were issued to him at his residential address through O/C Hemtabad PS, Uttar Dinajpur with a direction to join his duty vide this unit Org No- 1701/ RO, SPC Dated-18.10.2024. On 06.11.24 pm he reported his arrival at Reserve Office, Siliguri Police Commissionerate after unauthorised absent of 22 days. His unauthorized absence shows his lackadaisical attitude, gross negligence and dereliction of duty towards Govt. duty which is against of ethics of this disciplined Police department.

The charged officer ASI (UB) 314 Barku Mardi received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 06.03.2025. He submitted his written explanation on 11.03.2025, wherein he has pleaded guilty to the charge drawn up against him.

In view of all that has been stated above, it is evident that the Charged Officer is guilty of the charges framed against him in the departmental proceeding. He himself has pleaded guilty, which has confirmed that his admission of guilt is at his freewill after being fully aware of the charges and implication of his admission. Last but not the least, the documents having exhibited and confirmed by a prosecution witnesses concerned make it beyond all reasonable doubt as to the guilt of the Charged Officer of all the charges.

Considering the charges and his past service records, he should be meted out with punishment.

On 16.07.2025 the Charged officer ASI (UB) 314 Barku Mardi was heard by me personally, wherein he pleaded guilty.

After applying my mind judiciously, I pass the Final Order as:-

"The Pay of the Charged officer ASI (UB) 314 Barku Mardi is reduced by one increment w.e.f-01.08.2025 to 31.07.2026 for one year without cumulative effect. His absent period w.e.f 05.09.2024 am to 04.10.2024 p.m 30(Thirty) days is treated as E.L and absent period w.e.f. 16.10.2024 a.m to 06.11.2024 p.m 22 (twenty two) days is treated as E.O.L. Held over pay, if any, be released after necessary adjustment.

Suspension period of the Charged officer ASI (UB) 314 Barku Mardi w.e.f. 25.11.2024 p.m to 02.01.2025 p.m is confirmed that means Charged Officer will not get anything apart from subsistence allowance whatever he has drawn "

As per Rule 883 of PRB Vol -I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order

**FINAL ORDER PASSED BY SHRI TANMOY SARKAR , DY.  
COMMISSIONER OF POLICE (HQ), SILIGURI POLICE  
COMMISSIONERATE IN C/W THIS UNIT PROCEEDING NO-  
22/2024 DATED-04.10.2024 DRAWN UP AGAINST SI (UB) MD.  
SANAULLAH OF SILIGURI POLICE COMMISSIONERATE**

The charge as drawn up SI (UB) Md.Sanaullah is summarized below:-

While being posted at NJP PS under Siliguri Police Commissionerate he [SI (UB) Md.Sanaullah ] was entrusted to investigate NJP PS Case No-619/2024 Dated-26.06.2024 u/s-447/467/384/307/506/120B IPC and was directed to seized forged documents by the Ld. Court. As per Ordersheet dated-04.10.2024 of Hon'ble Calcutta High Court in the Circuit Bench at Jalpaiguri in c/w CRM (DB) 415 of 2024 with IA No- CRAN 1 of 2024 during the course of hearing, learned Advocate appearing for the state, stated that no documents was seized by the Investigating Officer. He, being the I.O of the case failed to comply the order and did not seized the forged documents as directed by the of the Ld. Court. His such act showed an aberration the ethics of disciplined department and tarnished the image of Police Department in the eye of common people.

The charged officer SI (UB) Md.Sanaullah received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 30.11.2024. In his written reply dated 04.12.2024, he did not plead guilty to the charges drawn up against him and preferred an open enquiry. The Proceedings File No. 22/2024 dated 04.10.2024 was endorsed to Shri Abdul Hai Sardar, Assistant Commissioner of Police (HQ), SPC for submission of findings at an early date. On completion of enquiry, Shri Abdul Hai Sardar, Assistant Commissioner of Police (HQ), SPC submitted his findings on 31.05.2025.

I have carefully gone through the deposition of prosecution witnesses, Defence witness, contents of exhibits, written statement

of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as 04 P.Ws, 02 DWs and concerned 12 documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the Charged Officer to defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 31.05.2025 with the opinion that the charge as levelled against Charged Officer SI (UB) Md.Sanaullah has been proved beyond any reasonable doubt.

On 16.07.2025 the Charged officer SI (UB) Md.Sanaullah was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, I pass the Final Order as:-

"The pay of the Charged Officer SI (UB) Md.Sanaullah is reduced by one increment w.e.f-01.08.2025 to 31.07.2026 for one year without cumulative effect."

As per Rule 883 of PRB Vol -I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.
