Whereas, information has been received from credible sources that violent demonstrations are likely to take place resulting in large scale disturbance of the public tranquillity and breach of the peace in the area mentioned in the schedule below of the NJP PS, under the Siliguri Police Commissionerate.

And

Whereas, I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Notification No. 1548-P.S. Cell/HR/O/3P-42/2014 dtd 16/08/2024 of Senior Deputy Secretary to the Govt. of West Bengal.

And

Whereas, in my opinion, there is sufficient ground for proceeding under the said section for immediate prevention of disturbances of public tranquillity and breach of peace within the area-in-question of the Siliguri Police Commissionerate.

And

Now therefore, in exercise of the power conferred by Sub-section (1)(3) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police

Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit for the period **60 (sixty) days** w.e.f **21st August 2025 to 19th October 2025** until further order, any assembly of 05 (five) or more person in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquillity and breach of the peace within the said area of NJP PS, Siliguri Police Commissionerate.

- 1) On the North by : Power Grid Guest House.
- 2) On the East by : Residential Apartment styled as "Basundhara Abasan".
- 3) On the West by : NH -34.
- 4) On the South by : Feeder Road at Kamrangaguri.

2. Prohibit assembly of **five (5) or more persons** within the radius of **100 (one hundred)** meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
3. Prohibit plying of loud speaker, microphone etc in and around **200** (two hundred) meters of examination venues. Use of Mobile Phones in an around **200** (two hundred) meters except the invigilators & venue in-charge is strictly prohibited; and
