CONST-1723 NURUL HASAN AT SILIGURI POLICE
COMMISSIONERATE

The charge as drawn up Const-1723 Nurul Hasan is summarized below:

A letter vide ref no. 417/PA-IGP, NBR dated 24.04.2025 was received from Shri Rajesh Kumar Yadav, IPS, Inspector General of Police, North Bengal Region, addressed to the Commissioner of Police, Siliguri Police Commissionerate, wherein it was reported that there had been a serious lapse in sentry duty at the IGP (NBR) Bungalow, Pintail Village, during the official visit of DG & IGP, West Bengal. That, as per the written report dated 30.04.2025 submitted by ASI (AB) 195 Jiten Thapa, In-Charge of IGP (NBR) Bungalow Guard Duty, he [Const-1723 Nurul Hasan] was detailed to perform sentry duty on 23.02.2025 from 02:00 hrs to 04:00 hrs. During the said duty hours, he was found sleeping and not alert at his designated post. At that time, both the DG & IGP, West Bengal, and the IGP, North Bengal Region, was residing at the bungalow, which is a high-security zone and sensitive location. His act of gross negligence by sleeping during active sentry duty in a high-security area constitutes serious misconduct, a clear breach of duty, indiscipline, and a violation of the professional code of conduct expected from a member of a disciplined department.

The charged Const-1723 Nurul Hasan received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 21.06.2025. In his written reply dated 23.06.2025, he did not plead guilty to the charges drawn up against him and preferred an open enquiry. The Proceedings File No. 17/2025 dated 20.06.2025 was endorsed to Shri Rabin Thapa, Assistant Commissioner of Police (East-I), SPC and submission of findings at an early date.

I have carefully gone through the deposition of prosecution witnesses, Defence witness, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as 03P.Ws, and concerned 02 documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the Charged Constable to defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 02.09.2025 with the opinion that the charge as levelled against Charged Const-1723 Nurul Hasan is partially proved beyond doubt.

On 26.09.2025 the Charged Const-1723 Nurul Hasan was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, pass the Final Order as:-

"The pay of the Charged Const-1723 Nurul Hasan is withheld by 01 (one) increment for one year from the next date of his due increment w.e.f-01.07.2026 to 30.06.2027 without cumulative effect."

As per Rule 883 of PRB Vol –I the Charged Const is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.
