Whereas, information has been received from reliable sources that smuggling and infiltration within 8 kms of Indo-Bangladesh International Border under Siliguri Police Commissionerate are causing / likely to cause grave danger to human life, property and public and a speedy remedy is necessary.

Now therefore, in exercise of the power conferred by Sub-section (1)(2) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 (2 of 2023) I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit movement of food grains and foodstuff i.e. rice, paddy, sugar, salt, wheat, pulses and other essential commodities and movement of trucks carrying cattle, livestock etc from 7-00 P.M each day to 6-00 AM next morning daily within 8 kms of Indo-Bangladesh International Border areas under Siliguri Police Commissionerate. In addition to this, grazing of cattle at night within 300 (Three hundred) meters of Indo-Bangladesh International Border is also prohibited from 7-00 PM each day to 6-00 AM next morning.

This order will take immediate effect and will remain in force from 26^{th} September 2025 to 24^{th} November 2025.

WHEREAS, information received from the Member Secretary, West Bengal Police Recruitment Board vide Memo No. PRB/Rectt./Cons._WBP (WE)/2024-989/2 (2) Dated 06.08.2025 and Org No.250 (33)/PRB/ Dated 08.09.2025 that the Preliminary Examination for Recruitment to the Post of Sub- Inspector (Unarmed & Armed Branch) in West Bengal Police -2024 scheduled to be held on 12.10.2025 (Sunday) in 01 (One) Session from 12.00 hrs. to 13.30 hrs at 36 (Thirty Six) Examination Venues of Siliguri Town Centre (Code No. 13) and Jalpaiguri Town Centre (Code No. 07) under Siliguri Police Commissionerate. A Total number of Candidates (Male-13478 + Female-1823 + Third Gender-2) 15303 (Fifteen Thousand Three Hundred and Three) are supposed to appear in that Preliminary Examination;

WHEREAS, there is apprehension of breach of peace and tranquility on the day of examination in the vicinity of the examination venues;

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquillity on the aforesaid day in and around the examination venue;

NOW, THEREFORE, in exercise of the power conferred by sub sec (1) read with sub sec (3) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 (2 of 2023) I, C. Sudhakar, IPS, Commissioner of Police, Siliguri and Executive Magistrate in relation to the Metropolitan area of Siliguri and being empowered so to do by the State Govt. do hereby-

1. I in exercise of power conferred upon me U/S- 163
BNSS I do hereby direct that **5 (five) or more person**, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the

compound/ premises/ around the venue of said examination; and

- 2. Prohibit assembly of **five (5) or more persons** within the radius of 100 (one hundred) meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
- 3. Prohibit plying of loud speaker, microphone etc. in and around 200 (two hundred) meters of examination venues. Use

of Mobile Phones in an around 200 (two hundred) meters except the invigilators & venue in-charge is strictly prohibited; and

- 4. I do hereby also prohibit entrance of any person(S) except those concerned with the conduct of the said examination
- within the compound of the examination venue after the commencement of the examination till the completion; and
- 5. Prohibit all the Photo Copying Centre's located within 100 meters from the examination venues on the **day**

(12/10/2025) of examination from 0.7:00 hrs till examination process is over.

Whereas, I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Notification No. 1548-P.S. Cell/HR/O/3P-42/2014 dtd 16/08/2024 of Senior Deputy Secretary to the Govt. of West Bengal.

Whereas, in my opinion, there is sufficient ground for proceeding under the said section for immediate prevention of disturbances of public tranquillity and breach of peace within the area-in-question of the Siliguri Police Commissionerate.

And

Now therefore, in exercise of the power conferred by Sub-section (1)(3) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit for the period 60 (sixty) days w.e.f 20th October 2025 to 18th December 2025 until further order, any assembly of 05 (five) or more person in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquillity and breach of the peace within the said area of NJP PS, Siliguri Police Commissionerate.
