While on the time of cordoning off the place the persons who were having liquor at the shop manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 20.25 hrs to 20.55 hrs.
