Sir,

I, SI Gautam Mallik presently posted at your kind disposal at New Jalpaiguri PS, Siliguri Police Commissionerate would like to lodge this written complaint against the arrested accused named Mijanur Shaikh (23 yrs) S/O Hishab Ali Shaikh of Vill- Siligram, PS- Nakashipara, Dist.- Nadia who had been arrested for contravening the norms of NDPS Act and also would like to produce before you one black colour Plastic Packet Containing Brown Sugar weight 148 Grams to the effect that today i.e. on 02/03/2021 at about 18.25 hrs myself received a secret source information that one person carrying a good quantity of Brown Sugar from Phansidewa side in his possession which is to be headed to Siliguri for transporting the same to other parts of the country clandestinely.

Wasting no time, I diarised the information in New Jalpaiguri PS General Diary Book vide GDE No 93 Dt. 02.03.21 and consequently informed of the tip off to you and Sri Pasang Topgay Bhutia, ACP Traffic (West), Siliguri Police Commissionerate for kind instruction. On being directed, myself along with ASI Khagen Barman, C/1053 Paresh Rava, VP/08 Laxman Roy, VP/13 Jamirul Islam left PS at 18.35 hrs for perusing the information. The process of informing to superiors and myself going out of PS for the purpose had been diarised in GDE No 93 and 94 respectively of NJP PS, dated 02.03.21. This is to note here that there was not enough time to obtain search warrant and there was a chance to miss the information, hence I did not obtain any search warrant.

While going to Fulbari near Toll gate I had been to the Gold Shop of one local gold smith named Biswajit Karmakar S/O Gaur Chandra Karmakar of Balaka More PS, NJP Dist. JPG who is a gold smith by profession & after submitting written requisition I took the certified weighing machine from him for the purpose of weighing if any search and seizure required. After arriving Fulbari near Toll gate at 19.15 hrs, I contacted two local persons namely (1) Babai Ghosh S/O late Mantu Ghosh of Purba Dhantala, PS- NJP, Dist.- Jalpaiguri (2) Sukamal Sengupta @ Lepcha S/O late Subir Sengupta of Shaktigarh, Road No - 3, PS- NJP, Dist.- Jalpaiguri and make them aware of the information in hand and requested them to act as witness if any search and seizure would be made necessary upon which they agreed.

Thereafter we along with the independent witnesses started weighting, after a while at 19.35 hrs the source that was waiting for us there pointed towards a person who was coming from Phansidewa Side suspiciously. Wasting no time we cordoned the said person from all sides to avoid any chance of him fleeing away. Thereafter we disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. As the person trying to hide some article from Police and there was strong reason to believe that the article is very much suspicious and it is brown sugar.
