- (1) One silver colour Local Hand made pistol having length 22" including wooden but having length 10"marked at "Exhibit A".
- (2) One live 8mm KF cartridge marked as "Exhibit B".

I, SI Thupden Tshering Bhutia presently posted at Pradhan Nagar P.S., Siliguri Police Commissionarate would like to lodge this written complaint against the above noted accused person namely Md Jabbar (34), S/O- Md Ful of Gurung busty, South Baghajatin Colony, W/No-3, P.S.- Pradhan nagar, Dist- Darjeeling, who had been arrested in c/w Pradhan Nagar P.S. Case No- 59/21, Dated-08.02.21, U/S- 448/326/307/34 IPC, to the effect that today during PC remand period of Pradhan Nagar P.S. Case No- 59/21, Dated 08.02.21, U/S 448/326/307/34 IPC, I interrogate the said PC accused person. On interrogation he disclosed that he has hidden the arms at his house situated at Baghajatin Colony. Accordingly myself along with SI Samik Paul, ASI Debasish Das, ASI Ashit Singha along with PC accused person Md Jabbar left for Baghajatin Colony vide Pradhan nagar P.S. GDE No 1198, Dated 21.02.2021. As per leading statement of the PC accused and on being shown by him on 21.02.2021 at about 23.40 hrs I recovered one silver colour Local Hand made pistol having length 22" including wooden but having length 10" loaded with one live cartridge having 8mm KF, from the house of the PC accused person namely Md Jabbar. On further interrogation he stated he was used to commit the crime on 08.02.2021 and he had fired 2-3 round from the said pistol towards Ayaj Hossain @ Raj and Dilip Mahato. I accordingly seized the said pistol along with one live cartridge having 8mm KF, under proper seizure list in presence of witnesses, duly signed by them and after completion all formalities returned back to P.S. subsequently.

In the above circumstance, I pray before you to start a specific case against the above noted accused person namely Md Jabbar (34), S/O- Md Ful of Gurung busty, South Baghajatin Colony, W/No-3, P.S.- Pradhan nagar, Dist- Darjeeling, under proper section of law and arrange for its investigation.
