1. That today i.e. on 25.02.2021 at about 10:00 a.m. when I was returning from the Market with the vegetables at that time one Munni Barman, Wife of Sanat Barman, resident of Salbari, Naya Busty, P.O. Salbari, P.S. Pradhan Nagar, Dist. Darjeeling was standing on the middle of the road alongwith two other people obstructing my way. At that time I request the said Munni Barman to provide me a side so that I can go to my home. But instead of giving me the way she abused me with filthy languages and also started assaulting me with bamboo stick hearing my hue and cry, my minor daughter named Chandi Khatun came out of my house and tried to protect me. It is not out of place to mention here that the said Munni Barman also physically assault my daughter with bamboo stick resulting which my daughter received injuries to her shoulder and back. It is pertinent to mention here that I also received injuries on my shoulder and back hand.

Now being aggrieved I am requesting you to investigated the matter and take necessary legal action against her.
