house apart in rent at Daleshin Kalash from our house was also not seen from 22/02/2021. His brother-in-law Ranjit Kanti (Lambu) who stays at Daleshin Kalash know him, so I went to his house to enquire about him. He said that Tulsi Kanti has gone to Bihar which is at village Suraj Bazar, Vadon Gram, P.S. Ghenshyampur, Dist. Darbhanga. I and my family believed that said Tulsi Kanti had kidnapped my daughter. Ranjit Kanti phoned Tulsi Kanti at Bihar and came to know that my daughter is with him. I and my wife with Ranjit went to his village, Ranjit took me to Tulsi village and kept us at a distance and showed my daughter, but Tulsi refused to talk with us, they take my daughter in their house. We were forced to return back without talking to her.

Sir, said Tulsi Kanti has kidnapped my daughter and confined her in his village and threatened us to harm my daughter if we try to bring her back. I therefore request you to take necessary legal action against Tulsi Kanti and others involved in kidnapping of my daughter and recover my daughter from their hands.
