With due respect, I Smt. Lata Barman, W/O Sri Tapash Roy & D/O Sri Dwijendra Nath Barman, resident at C/O Sri Dwijendra Nath Barman, Goursingh Jote, Uttar Ramdhan, P.O. Dulal Jote, P.S. Kharibari, Dist. Darjeeling would like to inform you that I am a married woman and my marriage has been solemnized with Sri Tapash Roy, S/O Ranjit Roy of Aambari, Falakata, Sudamganj, P.O. Kamarbhita, P.S. N.J.P, Dist. Jalpaiguri on 12.07.2020, performing all ceremony according to Hindu rights and customs. At the time of our marriage my father has given gold ornaments owing to weight 4 bhari and a complete set of all house-hold furniture, T.V., Fridge, etc. as dowry as per the demand of my father-in law. Soon after the marriage I had started to live with my husband at his residence. From the beginning of my conjugal life under the provocation of my mother-in-law, my husband and father-in-law and my brother-in-law and his wife started torture upon me both physically and mentally, they have pressurized me to take a sum of Rs. 1,00,000/- (Rupees One Lac) from my father, when my father failed to give the aforesaid money, they refused to provide me meal frequently. Most of the night I was compelled to sleep with empty stomach. Several time my husband and in-laws have beaten me mercilessly. Not only so they are not allowing me to talk with any neighbor or mix with anybody else. They were doing the same out of their apprehension if I am expressing the incident of torture to their neighbour. My husband along with in-laws torture was gradually increasing day by day, so looking no alternatives, my parents took me return to my paternal house on 07.09.2020 and since then I am residing with my parents.

Therefore, I request you to please investigate the aforesaid incident and take appropriate step.
