Sir,

With due respect it is to inform you that today ie., 05.03.2021 at about 11.00 hrs. or  
Ram Poddar S/O Sambhu Nath Poddar of 1/35 Gorakbashi Road , Nager Bazar North 2  
Paraganas , Pin 700028 entered into India through Fulbari ICP from Bangladesh bearing  
Indian Pass Port No. M 5490345 . Date of issue 13.01.2015 , Date of expiry 12.01.2025  
VISA no 91/0361/12/20/12662 , VISA Type Business - Multiple Date of issue 28.12.2020  
Date of expiry 27.12.2021 Came at Fulbari ICP, Siliguri, WB, India from Bangladesh for  
immigration clearance . During immigration clearing process Constable 214 Khandakar Alar  
of Fulbari ICP in Arrival Counter observed that the above noted person were LOC holder  
vide LOC NO.SIC'DY NO 41767DT. 10.12.2019 & 2019 from FRRO , BOI, Kolkata where  
he stated that "The subject has procured Indian Passport Number M5490345 and vote  
card bearing no IHM 2490324 fraudulently to settle in India along with his Bangladesh  
family members and instructed to seize the original passport and other IDs and  
thoroughly interrogate". Accordingly as per instruction of L.O.C. interrogated the passenger  
but he did not co-operate with the Police personal then I seized the original passport and  
arrested him and also narrating him cause of arrest nothing other documents found with him  
vide Fulbari ICP, G.D.E. NO 19 /21 DT. 05.03.2021 . Informed the fact to FRRO, BOI  
Kolkata over phone. It is clear from the LOC order that he fraudulently procure the Indian  
passport for illegal gain.

Hence ,I beg to pray that necessary legal action may kindly be taken as per law against the  
person Ram Poddar S/O Sambhu Nath Poddar of 1/35 Gorakbashi Road , Nager Bazar North 2  
Paraganas , Pin 700028 .
