Sir,

With due respect I am submitting a written complaint against one accused person namely Paritosh Singh (40) S/O Brij Kishor Singh of Gandhinagar ,W/no-43 PS-Bhaktinagar Dist-Jalpaiguri and producing herewith the following seized articles as per proper seizure list:

1. Sixteen (16) Bottle of Himalayan Gold Country Spirit (each bottle containing 600 ML) .

I, SI Sajal Roy of Bhaktinagar PS,SPC lodged a written complainant against the above noted person to the effect that today i.e. on 01.03.2021 hrs at 20.45 hrs received a source information that at Shiv Hotel ,Sevok Road ,Bhaktinagar some persons have gathered huge amount of liquor illegally inside the hotel for selling the same in the customer for their wrongful gain. This refers to Bhaktinagar PS GDE no-44 dated 01.03.21. I informed I/C Bhaktinagar about the information . As per his kind instruction I along with, ASI Rabin Lama,C/ 762 Majibur Rahaman , C/374 Debraj Biswas and CVF/619 Dharmendra Roy as proceed to Sevok Road ,Shiv hotel to work out the information. At 21.05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Shiv Hotel ,Sevok Road and recovered the above noted articles from the shiv hotel and one person fled away from the shiv hotel after seeing the police party and it is learnt from the witnesses that one person namely Paritosh Singh (40) S/O Brij Kishor Singh of Gandhinagar ,W/no-43 PS-Bhaktinagar Dist-Jalpaiguri selling the same in the customer and after seeing the police party he fled away from his shiv hotel and also learnt that he sell the same in the customer since long for his wrongful gain without any valid documents. In presence of witnesses namely Munna Singh (25) S/O Brij Kishor Singh of Gandhinagar ,W/no-43 PS-Bhaktinagar Dist-Jalpaiguri. Accordingly I seized the above noted articles from the Shiv Hotel after preparing proper seizure list and took signature of the witnesses. The seizure was made between 21.25 hrs to 21.45 hrs.

I therefore request you a specific case may kindly be started against the accused person namely Paritosh Singh (40) S/O Brij Kishor Singh of Gandhinagar ,W/no-43 PS-Bhaktinagar Dist-Jalpaiguri under proper section of law.
