With due respect I beg to state that I ASI Biswajit Saha of Bhaktinagar PS under Siliguri Police Commissionerate. While performing night mobile duty On 19/20.09.2020 at about 03.00 hrs as per source information myself along with CV-14 Labanyamoy Barman and CV-233 Amit Mallick reached at Gitalpara, near Anchal under Bhaktinagar PS, Dist.-Jalapiguri and found one vehicle (TATA ACE) having Registration No WB73B1879 loaded with 02(two) Cow was laying in abundant condition. No one turn up to claim that for vehicle and cow. Finding no other alternative I seized the Vehicle (TATA ACE) having Registration No WB73B1879, Engine No-275IDI05TZ5 22564 and Chassis No- 445010FTZR22373 loaded with 02(two) Cow One Red colour Female Cow with small Horn ,Age approx 06 years and One white colour Female calf without Horn, age approx 03 years under proper seizure list duly signed by the witness as per provision of 102 Cr.
