Sir,

In producing herewith the following accused namely (1) Ajay Mahanta (23) S/O Lt. Dulal Mahanta of Routh Bari more PO Ghugumali P.S Bhaktinager Dist Jalpaiguri (2) Goutam Banik (37) S/O Gopal Banik of do and (3) Nikhil Das (44) S/O Late Sasthi Charan Das of Purba Rabindra Nager Ward no. 38 PO Rabindra Sarani PS Bhaktinager Dist Jalpaiguri in custody along with the following seized articles:-

- i) One Khukri measuring about 11 inches in length made of iron including its Fiber butt was recovered from the possession of accused Ajay Mahanta (23) S/O Lt. Dulal Mahanta of Routh Bari more PO Ghugumali P.S Bhaktinager Dist Jalpaiguri.
- ii) One Iron made rod (house breaking implement) measuring about 20 inches in length was recovered from the possession of accused Goutam Banik (37) S/O Gopal Banik of Routh Bari more PO Ghugumali P.S Bhaktinager Dist Jalpaiguri
- iii) One iron made Chopper measuring approx 16 inches length including handle recover from the possession of accused Nikhil Das (44) S/O Late Sasthi Charan Das of Purba Rabindra Nager Ward no. 38 PO Rabindra Sarani PS Bhaktinager Dist Jalpaiguri.

I, S.I Swapan Ghosh of Ashighar OP P.S Bhaktinager would like to lodge this written complaint against the above noted accused persons and also 09/10 other unidentified persons to the effect that today i.e. on 04.03.2021 at about 21.05 hours received a secret source information that a group of 12-13 persons have assembled at Shahu River bed Near Tharughati forest, under Bhaktinager P.S, Dist-Jalpaiguri with deadly weapons with a view to commit some heinous crime. Accordingly without wasting any time I informed the matter to I.C, Bhaktinager P.S and diarised the whole fact in Ashighar OP GDE NO.96 dated 04.03.2021 Then at 21.10 hrs, as per instruction of O.C Ashighar OP I along with ASI Inzamamul Hoque, ASI Dipankar Banerjee C/134 Ginen Basumata , CV/616 Ananda Das all of Ashighar OP left for spot to verify the veracity of the information and to work upon it, noted in Ashighar OP GDE NO.97 dt-04.02.2021. We reached near the spot as directed by the source at about 21.35 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that one could anticipate our movement. On way we met two respectable persons of the locality namely (1) Shankar Mandal (38) S/O Late Sunil Mandal of Ashighar Coloney PS Bhaktinager dist. Jalpaiguri and (2) Sujit Roy (35) S/O Sachin Roy of Naresh more Telipara PS Bhaktinager dist. Jalpaiguri and to whom we disclosed our motto and identity and asked them to accompany us if any search and seizure is necessary for the purpose and they agreed. We reached at the Shahu River bed near Tharughati forest at about 21.50 hrs and found a group of 12-13 persons sitting at the Shahu River bed near Tharughati forest. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 03 above referred accused persons. After apprehension the 03 persons disclosed their identity as noted above and also stated that there were 09/10 other persons with them and they were planning to commit a

dacoity on the house of a businessman at Naresh More area. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were seized as follows:-

- i) One Khukri measuring about 11 inches in length made of iron including its Fiber butt was recovered from the possession of accused Ajay Mahanta (23) S/O Lt. Dulal Mahanta of Routh Bari more PO Ghugumali P.S Bhaktinagar Dist Jalpaiguri.
- ii) One Iron made rod (house breaking implement) measuring about 20 inches in length was recovered from the possession of accused Goutam Banik (37) S/O Gopal Banik of Routh Bari more PO Ghugumali P.S Bhaktinagar Dist Jalpaiguri
- iii) One iron made Chopper measuring approx 16 inches length including handle recover from the possession of accused Nikhil Das (44) S/O Late Sasthi Charan Das of Purba Rabindra Nager Ward no. 38 PO Rabindra Sarani PS Bhaktinager Dist Jalpaiguri.

.Thereafter all the articles were seized in-between 22.05 hrs to 22.25 hrs. issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested after observing all formalities of arrest them as they are assembled for committing heinous crime.

On the above circumstances, I pray before you that a specific case may kindly be started against the 03 arrested accused persons namely (1) Ajay Mahanta (23) S/O Lt. Dulal Mahanta of Routh Bari more PO Ghugumali P.S Bhaktinagar Dist Jalpaiguri(2) Goutam Banik (37) S/O Gopal Banik of do and (3)Nikhil Das (44) S/O Late Sasthi Charan Das of Purba Rabindra Nager Ward no. 38 PO Rabindra Sarani PS Bhaktinager Dist Jalpaiguri and 09/10 others unidentified persons for such assemble with deadly weapons and arrange for its investigation.
