Sub: Complaint against the Director, Manager and other officials and its agent Debu Barman of "Satin Credit Care Network Ltd.", a company registered under the Company Act, having its head office at 5th floor, Kundan Bhawan, Azadpur, commercial complex, Azadpur New Delhi and one of its branch office inter alia at near Ashighar more, P.O. Ghogomali, P.S. Bhaktinagar, Dist- Jalpaiguri .

Respected Sir,

I, Goutam Ghosh, Son of Mangal Ghosh, residing at Vivekanda Nagar, ward no.42, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against Director, Manager and other officials and its agent Debu Barman of "Satin Credit Care Network Ltd.", a company registered under the Company Act, having its head office at 5th floor, Kundan Bhawan, Azadpur, commercial complex, Azadpur New Delhi and one of its branch office inter alia at near Ashighar more, P.O. Ghogomali, P.S. Bhaktinagar, Dist- Jalpaiguri, to the effect that my wife Rina Ghosh had availed a loan of Rs.45000/- on 02-01-2021 at an EMI of Rs.2,250/- for a period of 13 months and/or 52weeks, the said installments was being paid punctually on the stipulated date and time however, on 28/02/2021 one of the agent namely "Debu Barman" having phone no. 7617595216 of the said company came to my residence and humiliated and insulted in front of the local public for delay of not paying the installment amount within a stipulated time and threatened her to pay the installment instantly then and there, but my wife several times requested him to come afterwards, as she would manage the amount for paying the aforesaid installment, despite of the same, he rigorously insisted to pay at once and told her to die by committing suicide and if she dies even then also she has to pay the installment. The agent said "Debu Barman" induced, incited and insisted upon my wife to commit suicide by humiliating and insulting openly before the local public and due to his inducement, incitement and on instigation, my wife on 01/03/2021 at about 5:30pm – 6:00pm, tried to commit suicide by putting fire on her person and as a consequence, she sustained 90% burn, and thereafter she was immediately rushed to Siliguri District Hospital and after seeing her condition the concerned doctor referred her to NBMC and presently she was admitted in NBMC and ultimately on 06-03-2021 at about 9:45 pm to 10:00 pm, she succumbed to her burn injury at NBMC.

That the agent, said Debu Barman, the above-named company is involved in abetting my wife to commit suicide and due to creating mental pressure, harassment and traumatized her and thereby compelled her to commit suicide.

So, therefore, I humbly request your goodself to take necessary legal action as per provision of law against aforesaid agent said "Debu Barman", the Director, Manager and other officials of the abovenamed company at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
