Sir,

I, Sri Parimal Roy, Son of Late Laxmi Kanta Roy, resident of Eastern Bye Pass Road, Purba Chayanpara, Post office- Ghughumali, Police Station- Bhaktinagar, District- Jalpaiguri, would like to inform you that I am carrying on a business of Hardware and accessories under the name and style as "Aluminum Worker's Mansion" having its shop at Eastern Bye Pass Road, Purba Chayanpara, Post office- Ghughumali, Police Station- Bhaktinagar, District- Jalpaiguri at about 6.30 p.m. when I was in my shop one Bhaskar Mitra, son of Late Amiya Kumar Mitra resident of Odyssey House, Satyen Bose Bye Lane, Babupara., Siliguri came in front of my shop and called me to come out from the shop as he had some urgent discussion with me. When I came out from the shop he started to shout at me with filthy languages and demanded a sum of Rs.50,000/- (Rupees Fifty thousand) only otherwise he will kidnap my daughter and commit rape on her. Hearing this sort of offensive statement I objected to it and all of a sudden Bhaskar Mitra become very violent and started assaulting me with fists and blows. By that time Bhaskar Mitra took out a iron puncher from his pocket and punched at my mouth by saying "tui taka na dile aajke toke merci felbo" and due to his violent attack with iron puncher I have sustained severe injury in my mouth and I have fallen down and it started bleeding from my upper lip. At that point of time Bhaskar Mitra snatched away a sum of Rs12300/- (Rupees Twelve thousand three hundred) only from my pocket fled away. Thereafter I have been taken to the

Siliguri District Hospital where the attending doctor in Emergency department treated me and I got three stitches in my upper lip. Bhaskar Mitra deliberately attacked me with dangerous weapon with an intention to rob me and kill me. He committed theft on me and has stolen a sum of Rs.12300/- (Rupees Twelve thousand three hundred) only from my pocket. It is pertinent to mention here that at the time Bhaskar Mitra also threatened me that I have to close/shut down my business forever in the said locality otherwise he will come again and kill me.

I hereby request you to look into the matter and book the culprits in accordance with appropriate provisions of law.





