I, **Smt. Menaka Saha**, Wife of Sri Bhupen Saha, aged about 65 years, resident of Uttar Shanti Nagar, P.O. Dabgram, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against my son Bakul Saha and my Daughter-in-law, Sefali Saha, resident of Uttar Shanti Nagar, P.O. Dabgram, P.S. Bhaktinagar, Dist. Jalpaiguri to the effect that since last 8 months my son said Bakul Saha and my Daughter-in-law, said Sefali Saha has been continuously hurling verbal abuses and committing mental and physical torture upon me and my husband.

I along with my old aged husband aged about 76 years have no source of income and my son and daughter-in-law have not been maintaining us properly. They have been continuously treating us inhumanly and behaving rudely due to which we have been suffering from mental pain and agony.

Received on 07-03-21 at 21.05h vide MS&AP. Code No 173 dt 07-03-21 and forwarded to SDC BKR PJ for starting a specific case related to ss Boudhjit Biswas for the investigation
That on 04-03-2021, my son and my daughter-in-law hauled, manhandled and disrobed me and physically assaulted me by fists and blows and due to which I sustained bodily pain on my person.

I had a severe bodily pain due the aforesaid physical assault by them and I was not able to tolerate the same and my younger son took me to Siliguri District Hospital, Siliguri for my treatment on 06-03-2021

So, therefore, I humbly request your goodself to take necessary steps against my son and daughter-in-law above-named at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
