Sir,

With due respect I am submitting a written complaint against one accused person namely Sunny Rai (26) S/O Sanjay Rai of Salugara, Rajfapri PO-Baikunthapur PS-Bhaktinagar Dist-Jalpaiguri and producing herewith the following seized articles as per proper seizure list:

1. Three (03) Bottles of Kingfisher Premium Lager Beer (each bottle containing 650 ML).
2. One (01) Bottle of Kingfisher Strong Premium Beer containing 650ML.
3. Two (02) Bottle of Old Monk XXX Rum (each bottle containing 750 ML).
4. One (01) Bottle of Royal Stage Deluxe Whisky partly filled.
5. One (01) Bottle of Mc Dowells No-1 reserve whisky party filled.
6. One (01) Bottle of Sterling reserve rare blended Whisky partly filled.

I, SI Sajal Roy of Bhaktinagar PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 07.03.2021 at 21.05 hrs received a source information that at Samjana Restaurant, Salugara, Rajfapri some persons have gathered huge amount of liquor illegally inside the restaurant for selling the same in the customer for their wrongful gain. This refers to Bhaktinagar PS GDE no- 321 dated 07.03.21. I informed I/C Bhaktinagar about the information. As per his kind instruction I along with ASI Rabin Lama, C/ 762 Majibur Rahaman, C/374 Debraj Biswas and CVF/619 Dharmendra Roy as proceed to Salugara, Rajfapri, Samjana hotel to work out the information. At 21.35 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Samjana Hotel, Salugara, Rajfapri and recovered the above noted articles from the samjana hotel and one person fled away from the samjana hotel after seeing the police party and it is learnt from the witnesses that one person namely Sunny Rai (26) S/O Sanjay Rai of Salugara, Rajfapri PO-Baikunthapur PS-Bhaktinagar Dist-Jalpaiguri selling the same in the customer and after seeing the police party he fled away from his samjana hotel and also learnt that he sell the same in the customer since long for his wrongful gain without any valid documents. In presence of witnesses namely Ramesh Rai (48) S/O Bhakta Bdr. Rai of Rajphapri, Dabgram(I) PS-Bhaktinagar Dist-Jalpaiguri. Accordingly I seized the above noted articles from the Samjana Hotel after preparing proper seizure list and took signature of the witnesses. The seizure was made between 21.55 hrs to 22.15 hrs.

I therefore request you a specific case may kindly be started against the accused person namely Sunny Rai (26) S/O Sanjay Rai of Salugara, Rajfapri PO-Baikunthapur PS-Bhaktinagar Dist-Jalpaiguri under proper section of law.
