Respected Sir,

In producing herewith one accused person namely Supriya Das @ Raj (20) S/O Rathin Das of Binoy More, Pipe line, PS- Bhaktinagar, Dist- Jalpaiguri along with seized articles viz- 1) 50 (fifty) bottles of "Chlorpheniramine Maleate & Codeine Phosphate Cough Syrup" styled as PHENCYREX containing 100 ml each having batch no. 181220-SMB1, Mfg date-DEC,2020, Exp date- NOV,2022 AMOUNTING of Rs.104/- each ,2) One Gray Color TVS Jupiter Scooty bearing no. WB-74AX-1826, and 3) one plastic bag to the effect that today i.e 01.03.21 at 20.05 hrs I received a secret information that one person was coming with one scooty bearing no. WB-74AX-1826 towards Hatimore, Subhashpally under Siliguri PS with huge quantity cough syrup illegally to dispose off the same at Court more under PS Siliguri. I diarised the matter Vide Siliguri PS GDE No. 47 dated 01.03.21 and informed to I/C Siliguri PS. As per direction of I/C Siliguri PS myself along with ASI Subir Sen, ASI Siben Sarkar , CV-145 Bijay Das and CV-622 Ramanath Barman left for Hatimore, Subhashpally under PS Siliguri to verify the veracity of information vide Siliguri PS G.D.E no. 48 dated 01.03.21. At about 20.25 hrs we reached at Hatimore, Subhashpally under PS Siliguri. Then we started a Naka Checking there. After a few a minute, as per identified by source we managed to apprehend the above noted person there by the help of local people.

In presence of the witnesses I found that the above noted person was riding the said scooty. On searching. I found that 50 (fifty) bottles of "Chlorpheniramine Maleate & Codeine Phosphate Cough Syrup" styled as PHENCYREX containing 100 ml each having batch no. 181220-SMB1, Mfg date-DEC,2020, Exp date- NOV,2022 amounting of Rs.104/- each in a plastic carry bag which was kept concealed in the Diggi of the said Scooty. I interrogated the above noted person who disclosed his identity as noted above. On demand he could not produce any document in support to carry/selling the above noted Cough Syrup and confessed that he procures the same illegally with intension to sale to young people at Courtmore area under Siliguri PS for his wrongful gain. So I Seized and labeled the above noted mentioned seized articles under proper seizure list in presence witnesses duly signed by the witnesses and arrested the above noted accused person u/s 41 Cr.PC after issuing Memo of arrest. The seizure and lable was made in between 20.55 hrs to 21.35 hrs.

I, therefore, pray to your kind honour that a specific case may kindly be started against accused person namely Supriya Das @ Raj (20) S/O Rathin Das of Binoy More, Pipe line, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law.
