I, Rajida Khatun (18) w/o Md. Alauddin, resident of Tyoti Nugar Colony, ward No 4 SMC, P.O-Siliguri Bazar, P.S-Siliguri, Distt-Darjeeling, do hereby inform you that on Dt. 01.03.2021 at about 08.10 pm, when my relative namely (1) Munni Begum w/o Md. Mustafa (2) Md. Babuddin w/o Md. Jahir were at their home at Tyoti Nugar at that time the following persons namely (1) Md. Safizul w/o Md. Lafua of Tyoti Nugar Colony, ward No. 04 SMC P.S-Siliguri, at that time ~~they~~ entered into their house and started abusing their family members namely (1) Md. Amiruddin w/o Md. Babuddin (2) Behana Khatun w/o Md. Babuddin and their relatives namely (1) Jasmin Khatun w/o Lt. Md. Sebbas (4) Habiba Khatun w/o Lt. Md. Ablao all are of Tyoti Nugar, when we protested the said Md. Safizul w/o Md. Lafua noted above, started beating us with fist & blows and attacked with a sharp cutting weapon on my relative (1) Md. Babuddin (40) & (2) Munni Begum, and both of them received severe injury on their person and immediately shifted to Siliguri Hospital by Tyotsna Khatun & Behana Khatun and Jasmin Khatun w/o Lt. Md. Sebbas also received severe injury on her person & admitted to Siliguri Distt. Hospital.

Received a written complaint on 01.03.21 vide Khalpura POP AD E No- 41 dt- 01.03.21 and forwarded to I/c Siliguri P.S. for starting a specific case under proper section of law. ASI Kalachand Singha will take up its investigation in anticipation of your kind approval.


