Siliguri Bazar, P.S-Siliguri, Distt-Bajelung, do hereby
inform you that on dt. 28.02.2021 at about 09.30 pm,
at night, my neighbours ~~came~~ entered into my house at
Coal Depo, noted above, namely (1) Md. Munna s/o md.
Abdul Barik @ Bhola (2) Md. Firoz s/o Md. Abdul Barik
@ Bhola (3) Md. Farhabet s/o md. Abdul Barik @ Bhola
(4) Rukhsana Begum w/o md. Abdul Barik @ Bhola (5)
Nazo Parvin w/o md. Munna, and started abusing me
and my family members namely, (1) Nigara Khatun @
Fatima D/o md. Charu (2) Subi Khatun (18) D/o md. Charu
(3) Md. Charu s/o md. Sher Ali, & (4) Md. Arman s/o md.
Charu, in filthy languages & when my mother namely,
Amira Begum w/o md. Charu, protested, he started
beating her brutally with fist & blows and injured
her grievously. We immediately shifted her to Siliguri
Distt. Hospital and admitted her there. They also dis-
mantled our household goods, and left from our house.

So, my mother, Amira Begum, have received severe
injury on her person & still under treatment at Siliguri
Distt. Hospital.

The above named alleged persons are very
desperate & dangerous in nature and they have
threatened us for dire consequences.

So, please take necessary action against them.
