**Sub - First Information Report**

Sir,

With Due Respect I, M.D Bhutto Khan, S/o Late Babujan Khan, address :-  
Dangi Para, Ward no 6, P.O Siliguri, P.S Siliguri, Dist Darjeeling would like to  
draw your kind attention to the following effects:-

1. That I am intending to marry of my sister namely as Kawshare Khatoon since one or two months.
2. That finally on 24.02.2021 one Asimuddin S/o Magiduddin , address :- Mukdugaess, Daspara, P.O Gandaghaz, P.S Chapra, WB, told me over his innocent boy (34) gave me a proposal that he wants to marry with very decent lady who belongs to very good family as because his first wife left him anywhere.
3. That there after on the very that day (24.02.2021) Asimuddin told me over his aforesaid cell phone that innocent person and very good character is in my hand and he is ready to marry.
4. That after that I told him to show or to bring out that person and his relatives at the house of my father-in-law.
5. That after on the very same date (24.02.2021), Asimuddin came alongwith Azizul Rahman and his uncle Rejaul Karim to the house of my father-in-law about the final discussion of marriage between my sister and Azizul Rahman.
6. That after, his uncle and principle accused told me to go along with them to their house, and I met, principle accused mother in principle accused house and told me that his son has already divorced with his first wife and has one child, and his wife has left them and child is under my custody.

7. That thereafter , I told the mother of the Azizul Rahman to go through the divorce paper and in my question she told me everything papers of divorce is in the question of my son and we will show the all papers at the time of given marriage.
8. Thereafter that , I returned at the house of my father-in-law and where in presence of Azizul Rahman, Rejaul Karim (uncle of Azizul Rahman) Asimuddin (Ghatak) and myself and my other family members and also bride and groom. And afterthat Azizul Rahman and Rejaul Karim forcefully and under presence triued to prepare as to make Nika but I told that presently I along with my family members not to make any Nikanama.
9. That Azizul Rahman and Rejaul Karim demanded Rs 200000/- as dowry from me but with the help of mediator name as Asimuddin the dowry amount has been settled amount of Rs 120000/- (one Lakh Twenty Thousand).
10. That thereafter both of Azizul Rahman and Rejaul Karim make false marriage agreement under the pressure, under influence and coercion with intent to cause damage or injury or to cause to part with my property, or to enter into express or implied contract, and with intend to commit fraud that may be committed, commits forgery.
11. That Azizul Rahman took Rs 5000 (Five thousand) from me as an advance dowry money with a promise to marry with my sister on 26.02.2021.
12. That accordingly, I along with my family members arranged the ceremony party and also purchased gold ornaments, bed and beddings, utensils and etc. to be given in marriage.
13. That on the date on marriage i.e 26.02.2021 after several request form my cell phone and also Asimuddin called them over his cell phone to come and to make Nikanama but they neither did not response nor to come at the house of my father-in-law to make Nikanama , as such they cheats and thereby induces to me and also with dishonest intention to takes Rs 5000 (Five thousand) from me, and destroy all the foods of huge amount which I have prepared for them to make Nikanama. And also falsely singed in marriage agreement.

That principal accused, Azizul Rahman and his uncle Rejaul Karim jointly in furtherance of the common intention with dishonestly, fraudulently and forcefully makes false marriage agreement which is to be forced and with dishonest intention misappropriate and cheated with us with give false promise to marry my sister (kawshar Khatoon).
15. That the above facts and acts and activities of Azizul Rahman and Rejaul Karim knowing fully and with dishonest intention intent to harm with our reputation in our society.

Therefore, under the above facts and circumstances it is prayed before you that you will be pleased to take necessary legal actions against accused persons and further be pleased to start proper investigation of the case and arrest the accused persons.
