That it is pertinent to note that the pandal was intentionally put on fire from three different sides and the consequences would have caused huge loss of life and property.

My neighbours rushed into my residence at around 3:00 AM to inform me about the said fire, and further informed me that two annonymous people were suspiciously seen moving through the streets shouting about the said fire.

I humbly request you to investigate the said incident and ensure the safety of my family and neighbours.
