Sir,

In producing here with the accused person namely-Bhabesh Debnath (30) yrs. S/O-Late Ram Debnath of Adarsha Nagar colony, ward No-4, P.S-Siliguri, Dist. Darjeeling, along with seized (i) 36 (Thirty six) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs- 3600/- (Tree thousand and six hundred) and ii) 15(Fifteen) bottle of Himalaya Gold 60 up Country spirit containing 300 ML in each bottle mentioning M.R.P of Rs- 50/- in each bottle i.e. total amount of Rs- 750/- (seven hundred Fifty) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1".

I beg to report that today i.e. on 03-03-21 while performing special raid against illegal alcohol, at 22.05 hrs I received a source information that one person namely- Bhabesh Debnath (30) yrs. S/O-Late Ram Debnath of Adarsha Nagar colony, ward No-4, P.S-Siliguri, Dist. Darjeeling, is selling huge alcohol in the house of the accd. Person at Jyotinagar colony, ward No-4, P.S-Siliguri, Dist. Darjeeling. Under Khalpara TOP without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for Jyotinagar colony, Siliguri to verify the veracity of the information vide Khalpara TOP GDE No - 137/21 Dated: 03-03-21. After reaching Jyotinagar colony,, Siliguri, Darjeeling at 22. 15 hrs and as shown by the source I found the above noted person is selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept in the house of the accd. Person a gunny bag. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 22.20 hrs to 22.45 hrs on 03-03-21.

Under the above noted law may kindly be started against the above noted arrested accused person namely fact and circumstances, I therefore, pray that a specific case under proper section of Bhabesh Debnath (30) yrs. S/O-Late Ram Debnath of Adarsha Nagar colony, ward No-4, P.S-Siliguri, Dist. Darjeeling for the possessing and selling alcohol illegally and arrange for its investigation.
