Dear Sir,

I, Dharmendra Rustogi, age 45 yrs., S/o Sri Kartarchand Rustogi resident of Vidyasagarpally, Ward No.VII, Khalpara, Siliguri :- 734 005 would like to inform you that yesterday at midnight some antisocial elements broke the glass doors of my shop M/s. Kartar & Co., situated at Nehru Road, (near Dhanoti Bhawan), Khalpara, after managing to open the shutter for forcible entry into my shop. The miscreants also damaged the office furnitures before stealing the following goods as per details below:-

- 1) Samsung Television set of 32"
- 2) Cash of Rs. 60,000/- approx.
- 3) Silver coins 11 pcs. meant for puja purpose
- 4) One Hand Bag consisting of important personal papers and documents relating to my shop and residence

Sir, the above items were found missing on first inspection only. I apprehend missing of more items on further inspection.

Sir, the footage of CCTV camera of the neighbouring building will help you in your investigation to apprehend the culprit.
