Subject : First Information Report

Sir,

I, **SRI SOURAV SARKAR**, Son of Sri Sudip Sarkar, resident of Sarada Pally, Ward No. 37 of SMC, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to draw your kind attention to the effect that on 04-03-2021 at around 12.30 AM I received a call from one Anit Kumar Das, Son of Jatindra Mohan Das, resident of Lake Town, Protibha Basu Sarani, Ward No. 33 of SMC, P.S. NJP, Dist. Jalpaiguri to the effect that he along with Krishnendu Sutradhar, Son of Kalipada Sutradhar of same locality was brutally attacked by TMC cadres near Indoor Stadium, Ward No. 27 of SMC. Immediately at around 01.00 AM I arrived to the spot and found the above Anit Kumar Das and Krishnendu Sutradhar were lying down by the side of the road and the Bullet Bike of Anit Kumar Das was also lying in a few meters away under broken condition. I also found the above victims under critical, unconscious nature and immediately shifted them to Siliguri Dist. Hospital. Wherein after gaining his consciousness in this morning, the above Anit Kumar Das informed me that when he along with above Krishnendu Sutradhar were returning to their house from attending a marriage ceremony, at around 12.10 AM they were blocked under compelling head at the above referred place by 1) Sanjay Dey, Son of Amar Dey, of Sahid Colony, Agrani Maidan Road, Ward No. 35 of SMC, 2) Baidya Sarkar, Son of Pradip Sarkar, of Poschim Bhaktinagar, Ward No. 35 of SMC, 3) Sanjit Paul, Son of Ajit Paul, of Surya Sen Colony, Near Desi Daru Bhutty, Ward No. 34 of SMC, 4) Sayan Mitra @ Bultan, Vice President, Town - 3, Trinamul Youth Congress, Siliguri, resident of Balaka More, Ward No. 32 of SMC, 5) Prakash Bardhan @ Ronaldo, Son of H.C. Bardhan, of Surya Sen Colony, Block - E, Ward No. 34 of SMC along with 15-20 others and on being asked about their said act, the above persons threatened them with dire consequences if they continue to work with BJP and insisted them to join TMC, on objecting to such proposal, the above persons started assaulting them physically with deadly weapons viz. iron rods, wooden sticks etc under merciless manner and also damaged the bike belonging to said Anit Kumar Das. Out of the said attack, they sustained grievous injuries to the effect of internal injury at head of Krishnendu Sutradhar, cut injuries, head, back, chest, shoulder etc. bodily injuries. Subsequently, Krishnendu Sutradhar fell unconscious on the road and the antisocial left the place and also said Anit Kumar Das lost his consciousness subsequently. It is right place to mention here that all the above persons are TMC Cadres. Also during such scuffling, they intentionally snatched one gold neck chain belonging to Anit Kumar Das, cash worth Rs. 12,000/- (Rupees Twelve Thousand) only from Anit Kumar Das's possession, also snatched his Titan wrist Watch and also on the other hand snatched cash worth Rs. 3,000/- (Rupees Three Thousand) only from said Krishnendu Sutradhar, snatched his wrist watch, they also damaged the bike of Anit Kumar Das. The above persons attacked them with preplanned manner under conspiring head to murder them and accordingly they attempted so with deadly weapons. Moreover, there is every apprehension of further deadly

attack upon them by the above persons, as they have oblique motive to kill them just for the reason of their involvement in BJP party. At present they are living under the panic and tremendous mental agony of harm to their life and limb and also under medication at Siliguri Dist. Hospital.

So it would be kind enough, if you treat this present complaint as First Information Report and take immediate drastic action/s against those above mentioned culprits along with their men by imposing strict penal as well as other provision/s for the proper administration of Justice.
