Sir,

In producing herewith one arrested accused person namely (i)Shibu Das(31) s/o-Ashok Das of Sarbannagar,Bagracote, w/n-18, PS-Siliguri Dist-Darjeeling (ii) Ramyad Mahato(58) s/o-Lt Tanuklal Mahato of Darjeeling more,Shivnagar,W/N-46 ps-Pradhannagar Dist-Darjeeling along with seized articles viz

1. 170(One hundred and seventy) bottles of Himalayan Gold 60 UP country spirit containing 600 ml. Each
2. 11(eleven) bottles of Officer Choice Deluxe Whisky containing 180 ml.each
3. 39(thirty nine) Pouch of Officer Choice Deluxe Whisky containing 180 ml.each
4. 11(eleven) bottles of Old monk XXX containing 180 ml.each
5. 33(thirty three) Bottles of Mc Dowell's no-1 celebration Rum containing 180 ml.each
6. 07 (seven) bottles of Kingfisher beer containing 650 ml each
7. 23(twenty three) bottles of Tuborg beer containing 650 ml each
8. 11(eleven) Bottles of Mc Dowell's no-1 Original containing 180 ml.each

I SI.Mrityunjoy Roy of Detective Department, Siliguri Police Commissinerate do hereby lodge this complaint against above noted accused persons to the effect that on 05.03.21 at 19.05 hrs received secret source information that two persons are illegally selling liquor inside the shop cum house at Bagracote area under Siliguri PS area without any valid license.

The information was diarised vide D.D, SMP GDE No- 524/21 Dt- 05.03.21 Accordingly I informed the matter to ACP-1, D.D, SPC and as per his kind direction myself along with SI.NUR ALAM SIDDIK,SI.DILIP DAS ,SI SANJIB PODDER ,C/813 GYANENDRA CH. SARKAR ,C/ 932- PABITRA DAS ,C/-945 KRISHNA BARMAN, C/-1054 ARABINDA ROY left for Bagracote area to verify the veracity of the source information. We reached at Bagracote area and found that one person was seating in a chair in front of his house and another was standing and selling liquor to the general people. Our police party held raid, after hot chase the said persons were apprehended by us. On interrogation, they confessed their guilt and admitted their name and identity as noted above as Shibu Das(31) s/o-Ashok Das of Sarbannagar,Bagracote, w/n-18, PS-Siliguri Dist-Darjeeling is the house owner and another

Ramyad Mahato(58) s/o-Lt Tanuklal Mahato of Darjeeling more,Shivnagar,W/N-46 ps-Pradhannagar Dist-Darjeeling is his business partner. During interrogation they admitted that they procured the said liquor in illegally from the Siliguri area and thereafter sell it in the open market for their wrongful gain. On demand they could not produce any license in support of the said liquor. Then I seized the above noted articles from the possession of identified apprehended persons and labelled in presence of local witnesses and prepared a seizure list and took signature of the accused persons and witnesses. The seizure was made in between 20.50 hrs and 21.30 hrs. Then I arrested the said accused persons U/S-41 Cr.PC and issued Memo of Arrest appraising the ground of arrest.

I therefore pray that a specific case may kindly be started against the accused persons namely (i)Shibu Das(31) s/o-Ashok Das of Sarbannagar,Bagracote, w/n-18, PS-Siliguri Dist-Darjeeling (ii) Ramyad Mahato(58) s/o-Lt Tanuklal Mahato of Darjeeling more,Shivnagar,W/N-46 ps-Pradhannagar Dist-Darjeeling under proper section of law and arrange for its investigation.
