Sir,

In producing herewith one arrested accused person namely Budhyadeb Biswas (Male/50) S/O-Lt Dhirendranath Biswas of Bidyachakra Colony, near Kali Mandir, W/No.44, PS-Bhaktinagar, Dist-Jalpaiguri along with seized articles 13(Thirteen) Bottles of 60 UP Country Spirit styled as PET Galaxy BOSS of 600 ml each when packed, MRP Rs. 100/- each 2) 01 (One) Nylon Bag which used for carrying the seized articles SL. N- 1.

I, ASI Ratan Ghosh of Panitanki TOP under Siliguri PS hereby lodge a written complaint against the above noted accused person to the effect that on 06/03/2021 at 20.35 hrs received secret source information that one person is carrying huge quantity of bottle country spirit through Sevoke Road, near Amar Garage, towards Bidyachakra Colony, Bhaktinagar. Accordingly informed to O.C Panitanki TOP and diarized the matter at Panitanki TOP vide Panitanki TOP GDE No 157 dated 06.03.21 and thereafter as per his direction I along with ASI Surajit Mallik, C/153 Santosh Mahato, CV-1009 Monoj Thakur, left from Panitanki TOP vide Panitanki TOP GDE No- 158 Dt- 06.03.21 at 20.45 hrs to work out the information. On arrival at Sevoke Road, near Amar Garage, Siliguri at 21.05 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I Intercepted the said accused person with loaded articles in presence of disinterested witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Bidyachakra Colony, Bhaktinagar adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized {1} 13(Thirteen) Bottles of 60 UP Country Spirit styled as PET Galaxy BOSS of 600 ml each when packed, MRP Rs. 100/- each 2) 01 (One) Nylon Bag which used for carrying the seized articles SL. N- 1 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 21.10 hrs to 21.35 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. Total value of seized articles is Rs.1300/-

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Budhyadeb Biswas (Male/50) S/O-Lt Dhirendranath Biswas of Bidyachakra Colony, near Kali Mandir, W/No.44, PS-Bhaktinagar, Dist-Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
