In producing herewith two arrested accused persons namely (I) Dipak Kamti @ Dipu (32) S/O Sri Satraguna Kamti of Debidanga Bazar, PO-Champasari, (Near G.P Office), PS Prodhan Nagar, Dist- Darjeeling and (II) Ganesh Sha (30) S/O Sri Mahadeb Sha of Sastri Nagar, Iskon Mandir Road, W-41, PS Bhakti Nagar, Jalpaiguri, A/P Lower Bhunu Nagar, Jha Building, W-43, PS-Bhalu Nagar, Jalpaiguri along with seized articles as per seizure list.

1. One improvised iron made one shooter fire arm in working condition measuring approx 9 inches from barrel to butt having striking pin, hammer and trigger.
2. One live ammunition bearing the label as QK 04 71 of 303 bore
3. One Silver colour Hyundai EON car having Registration No WB20AG/9350
4. Indian Currency Rs. 50,700/- (Rupees Fifty thousand seven hundred) only Denomination of currency (Rs. 500X101 + Rs. 50,500/- and Rs. 100X2 = Rs. 200/- Total Rs. 50700/- L.C.)

I, SI Rana Brahma of Panitanki TOP under Siliguri Police Station, Siliguri Police Commissionate do hereby lodge the complaint that, today on 07/03/21 at 00:15 hrs, I received a secret source information that two habitual criminal namely (I) Dipak Kamti @ Dipu (32) S/O Sri Satraguna Kamti of Debidanga Bazar, PO-Champasari, (Near G.P Office), PS Prodhan Nagar, Dist- Darjeeling and (II) Ganesh Sha (30) S/O Sri Mahadeb Sha of Sastri Nagar, Iskon Mandir Road, W-41, PS Bhakti Nagar, Jalpaiguri, is roaming at Surya Sen Park area with a car having Registration No. WB20AG/9350 with an ulterior motive and is in possession of fire arm. Accordingly I informed the matter to O/C Panitanki TOP as well as I/C Siliguri PS and diarised the matter at Panitanki TOP vide Panitanki TOP GD entry no 167 dated 07/03/21. Then at 00:25 hrs as per their kind instruction I along with ASI Gopesh Ch Barman, ASI Surajit Mallick, C/984 Subhasis Das, C/153 Santosh Manato all of Panitanki TOP left for Surya Sen Park area to work out the information. This refers Panitanki TOP GDE No 168 dated 07/03/21. At about 00:35 hrs we rushed at Surya Sen Park area and on way picked up two disinterested witnesses namely 1) Ranjan Sarkar S/O Li. Kulipada Sarkar of Mahanandapara, 23 Uday Shankar Sarani, W-10, PS Siliguri, Darjeeling 2) Krishna Roy S/O Lt. Bishwima Roy of Kashmit Colony, PS Njp Jalpaiguri, duly informing them about the information in hand. At 00:45 hrs we reached near Surya Sen Park Main gate and as per vehicles number supplied by the source, we detained the above noted vehicles and apprehended two persons noted above with all precautionary measures. On being asked, the apprehended persons disclosed their identity as noted above.

Accordingly, as per information and following all necessary procedures of search of the police person by the witnesses, search of the apprehended persons and vehicles were made. On search one improvised one shutter iron made fire arm loaded with one round live ammunition and Rs. 50,700/- (Rupees Fifty thousand seven hundred) only was recovered inside the dashboard of said vehicle. The ammunition was unloaded from the firearm as per practical experience.

On being asked about the possession of the fire arm and ammunition, the apprehended both persons confessed that, both they have clear knowledge regarding the above noted fire arm and ammunition which was kept at said vehicle.

As there is every reason to believe that the firearm and ammunition recovered has been procured dishonestly by the apprehended persons noted above for their ulterior motive, seized the firearm and ammunition duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledged by the apprehended persons and arrested them following all formalities. The seizure has done between 01:05 hrs to 01:55 hrs.

Office), PS Prodhan Nagar, Dist- Darjeeling and (II) Ganesh Sha (30) S/O Sri Mahadeb Sha of Sastri Nagar, Iskon Mandir Road, W-41, PS Bhakti Nagar, Jalpaiguri, A/P Lower Bhunu Nagar, Jha Building, W-43, PS- Bhakti Nagar, Jalpaiguri and arrange for its investigation.
