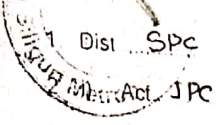

Sub: First Information Report.

Sir,

I, Sri Animesh Das, Son of Sri Ashok Das, Resident of Upper Bagdogra, P.S. Bagdogra, District – Darjeeling do hereby lodge this complaint against one Smt Ivy Das (aged about 31 years) of Ghoshpara Station Road, Near ITI More Bus Stop, Kalyani, West Bengal who is presently working for gain and residing at 408, United Daffodil, Bangalore, Karnataka – 560037 to the effect as follows:

1. That I being a software profesional being engaged with VISA and posted at Bangalore since the year 2016. I was on a holiday trip with my friend Avisekh Shaw in or about the first week of March, 2020. Whilst travelling in a bus and proceeding towards Joshimath, Uttarakhand, me and my friend Avisekh got known to the said Ivy Das in the said bus after hearing each other speak in the Bengali language. Ivy Das was accompnied by a male person namely Rupantar Guha of Hyderabad.
2. That on introduction in the said bus after we reached Joshimath we decided to stay in the same hotel. Ivy Das and Rupantar Guha shared the same room and myself and Avisekh got a separate room for ourselves. Contact numbers were exchanged between us since Ivy and myself worked for gain in the city of Bangalore.
3. That after reaching Bangalore on 14.03.2020 Ivy requested me to visit her place for tea on the 15th March, 2020 and I kept her request and paid her a visit to her place.
4. That thereafter, Ivy would get into long telephonic conversations with me and I could feel that she was slowly and steadily luring me in a relationship with her. As days passed by our acquaintance became a friendship but I wanted to keep the friendship without any physical intimacy.
5. That on one ocaasion, Ivy who is fond of drinking liquour literally forced me to have a drink or so. After both of us having a few drinks, Ivy forced herself on me and wanted sex, to which I protested and after rejecting her pursuation, Ivy got angry on me and started shouting at me. I tried to reason with her but she continued with her bad behaviour and asked me to leave.

6. That I was apprehensive of Ivy's multiple relationships with other males being strongly evidenced by the fact of her tour to Uttarakhand in the month of March, 2020 and sharing the same hotel room with Rupantar Guha.

7. That whatever emotions I had for Ivy was based on the fact that she being a lady in her mid-ages hailing from the same Bengali background and working in a big city as Bangalore.


8. That from the month of November, 2020 when I came back to my home at Bagdogra, Ivy used to continuously ring me and say that she felt very lonely and asked me to come back to Bangalore and that she needed financial assistance of a few lakh rupees from me. I told her that my financial position was not strong enough to assist her. Nevertheless in continuation of my work I took up a new assignment with Paypal Company w.e.f. 14th December, 2020 at Bangalore.

9. That Ivy constantly told me over telephone that due to excessive drinking and work load she was becoming depressive and needed my help and regularly she used to ask for money from me.

10. That I was finding myself being dragged into a sticky situation by Ivy with her constant pressure for money from me and also I found that Ivy has developed certain physic symptoms. On 6th December, 2020 the said Ivy called me over phone and threatened me that if I do not transfer her rupees one lakh immediately than she shall go to my new joining company and create scene over there and that my career and job would be ruined and out of fear I transferred Rs. 50,000/- on 07.12.2020 to the account of said Ivy Das via google pay being VPA: ivy.diya@okhdfcbank, A/C No. XXXX0934 (HDFC0002710), Transaction Id: S71406950 and Reference Number: 034221141018.

11. Thereafter on one occasion in the month of December, 2020 she purposely called my mother over telephone and levelled various allegations against me indicting me of having forceful physical relationship with her and she also used filthy language to my mother.

12. That after such incident I stopped all communication with Ivy on and from 25th December, 2020 and till 16th January, 2021 Ivy also did not keep any contact with me. On 17th January, 2020 when I was at Bagdogra, Ivy telephoned me and told me that if I immediately do not send her a lakh of rupees, she would commit suicide and leave a note entangling my entire family to be the cause of her suicide. She further threatened to defame me with various criminal allegations to my employers so that I am left with no job. Ivy did not stop her continuous pressure for money and blackmail which made me fearful of the consequences of me and my family being dragged into false criminal cases by Ivy and I was again compelled to send all the money I had in my account amounting to Rs. 65,750/- on 25th January, 2021 to the account of Ivy via Google Pay

13. That not being satisfied Ivy since the 2nd week of February, 2021 keeps threatening me over whatsapp that "I will ruin your career by filing a FIR against you", "See u in Court then", "will visit your girlfriends house and talk to her father and make sure she won't be able to marry you", etc. Screenshots of such messages are annexed along with this complaint.
14. That Ivy has gone to such extent and on threats of committing suicide and falsely implicating me in criminal cases has for the past few days threatening me to send her Rupees 5 lakhs immediately or else she will ruin my career, file false criminal cases against me and my family and make my life hell and destroy me in all aspects. She has also threatened that on my coming to Bangalore, she shall ensure that I shall be severely beaten up by her male friends and family members and that my life shall be in danger (such call recordings are kept in safe custody for your reference).
15. Due to such extortion of money since 7th December, 2020 by Ivy, I am under tremendous mental pressure and can no longer send any money to Ivy and hence approach your kind self to take appropriate steps against Ivy for the commission of criminal offences.
