Sub - Lodging complaint

Sir,

In producing herewith one arrested accused person namely Sajan Lama (28 yrs) S/O Krishna Lama of Vivekananda Pally P.S Bagdogra Dist Darjeeling along with seized (i) 02 (two) plastic Jar containing 10 liter Country sprit each (ii) 05 (five) Bottle Himalayan Gold Country Spirit 60 up 600 ml each.

I do hereby submit that on 03/03/2021 at evening I ASI Depak Biswas along with ASI Joydeep Dutta and force was engaged in special raid duty at Bagdogra PS area vide BDR PS GDE No.144Dt: 03.03.2021. In course of raid, as per source information I along with force intercepted the accused person namely Sajan Lama S/O Krishna Lama of Vivekananda Pally P.S Bagdogra Dist Darjeeling at his house. Accordingly, the matter was informed to O.C Bagdogra PS over telephone and as per direction of O.C PS, I along with force apprehended the accused namely Sajan Lama as noted above from his house with huge quantity of ID liquor / country sprit as noted above. On being asked the accused namely Sajan Lama failed to produce any valid documents as well as license for possessing and selling of ID liquor / country sprit. On interrogation the accused person confessed that he has been selling the same from his house at Vivekananda Pally P.S Bagdogra Dist Darjeeling area illegally. As such the accused person as noted above violated the provisions of W.B. Excise Act. Accordingly, I arrested him under proper memo of arrest and seized the recovered ID liquor/country sprit (as mentioned in the seizure list) under proper seizure list dully signed by the witnesses and accused person also. The seizure was conducted in between 20:05 hrs to 21:15 hrs. Thereafter I labeled the seized ID liquor/Country sprit/ Rum as noted above.

I, therefore pray that a specific case under proper section of law may kindly be started against the above noted accused person for violating the provisions of W.B. Excise Act.
