Subject : First Information Report

Sir,

I, Sri Sajal Biswas, Son of Sunil Kumar Biswas, resident of Khudirampally, P.S. Bagdogra, Dist. Darjeeling would like to draw your kind attention to the effect that on 03-03-2021 at around 10.30 PM when I was coming back from my work place to my above referred residence, 1) Raj Kiran Mallick, Son of Tarak Mallick, 2) Rajesh Dey, Son of Late Gouranga Dey, 3) Samrat Chando (Chhotu), Son of Late Ashim Chando, all are residents of Khudirampally, Bagdogra along with 8-10 others most illegally blocked my way near Khudirampally, Station More and without spending any words, took my Car's key and when I asked for the key after getting out of my vehicle, the above persons along with others started assaulting me physically with the aid of deadly weapons. During so, the above Rajesh Dey hit me by iron rod at my head and Raj Kiran Mallick hit me at my eyes with wooden stick and the others also hit me with various deadly means and out of the said sudden brutal attack, I fell on the road and found myself at Bagdogra Primary Health Center after getting my consciousness. It is to be mentioned here that the above persons during such assault, mentioned that they would finish me at that moment just for the reason of my involvement with BJP party. It is pertinent to mention here that all the above persons are TMC Cadres. Also during such scuffling, they intentionally snatched my gold neck chain, cash worth Rs. 7,000/- (Rupees Seven Thousand) only from my chest pocket, costly wrist watch. The above persons attacked me with preplanned manner under conspiring head to murder me and accordingly they attempted so with the aid of said deadly weapons and out of the said grievous attack, I sustained heavily head, eye, chest injuries and also got bodily internal as well as external injuries. Moreover, there is every apprehension of further deadly attack upon me by the above persons, as they have oblique motive to kill me and/or attack upon my family just for the reason of my involvement with BJP party, so I along with my family are living under the panic and mental agony of harm to our life and limb.

So it would be kind enough, if you treat this present complaint as First Information Report and take immediate drastic action/s against the above culprits along with their men and agents by imposing strict penal as well as other provision/s for the proper administration of Justice.
