First information report regarding seizure of 50 gm suspected brown sugar powder with Sub-

Sir.

It is to inform that today on 05.03.21 at about 1410 hrs specific information received from reliable source that a person is about to move with prohibited narcotics items may be "brown sugar" in the area of Panighatta more Bagdogra, distt- Darjeeling(WB) India. On the basis of input a special ops team consisting under the supervision of Sh. Santhosh Chandra, Assistant Commandant, Insp/gd Abhishek Singh parihar, asi/gd jintu Borah, hc/gd ajay Kumar Mallick, ct/gd Suraj Karjee, ct/gd bala ganesh, ct/dvr ramlal of f-coy Baramaniramjote 8th bn ssb have reached near the aforesaid place at 1500 hrs. About 1550 hrs the party identified 01 person at the location near panighatta more moving in suspicious manner with a black backpack. The special ops team gave its identity to suspected person and asked about the identity of the suspected person and the item inside the bag. On opening the bag, one plastic bottle containing lumps of suspected brown sugar, mini weighing machine and 01 no. mobile handset of Xiaomi having IMEI no. 868147034290189/868147034290197 and SIM No. 8991000903664223119U (Airtel). When asked about the details of suspected items he could not give any satisfactory reply and also could not give details of about the source of substance which was in his position. The SSB ops team asked about any authority or permission to carry suspected brown sugar and he failed to provide Any letter of authority or permission. Further, the substance suspected to be brown sugar was weighed using an electronic weighing machine available in nearby shop and it found to weigh 50 gm. The powdered substance was tested after the permission of suspected person namely Samar Mandal with help of drug detection kit available with the team and the drug detection kit gave positive indication of drug inside the pocket. Accordingly, the suspected drug was seized at about 1640 hrs. During the entire process, Sh. Santhosh Chandra, Assistant Commandant, of 8th Bn, SSB was present.

One sample of about 05 gm taken from the mother packet and both the mother packet and sample packet were labelled in the presence of witness and apprehended person. The packet was well sealed and labelled and signature in this regard made by this ssb ops team member and

apprehended person.

During the spot interrogation he revealed his name as Samar mandal (32 years) s/o subal mandal, Damodarpur, dharampur, malda, West Bengal-732202. He received the items from an unknown person. Medical examination of the apprehended person was carried out at bagdogra hospital. In pursuance of this case, the apprehended person namely Samar mandal, seized item suspected to be brown sugar with seizure memo have been handed over for lodging an FIR at your police station under relevant sections of NDPS Act.
