I, Sri Nirmal Tamang, Son of Late Dhan Bahadur Tamang, Resident of Shelpu Busty, P.O. Shelpu Busty, P.S. Kurseong, District- Darjeeling, do hereby lodge this complaint against one Ranjit Sinhga, son of Dhurpuru Singha, resident of Dhukuria, P.O. New Chamta, P.S. Matigara, District- Darjeeling to the effect as follows:

- 1. I have purchased a plot of land measuring 5.21 decimals for the purpose of building a residential house thereon vide a registered Deed of Sale being document no. 579 for the year 2011 registered at the office of the A.D.S.R. Siliguri II at Bagdogra and the said land has been mutated in my name by the concerned authority and the said land appertains to R.S. Plot No. 488 corresponding to L.R. Plot No. 446 and 448, New L.R. Khatian No. 2217, Mouza Dhukuria, J.L. No. 53, P.S. Matigara, District-Darjeeling.
- 2. Since the date of the aforesaid purchase I have been in absolute physical and peaceful possession of the said land. It would be pertinent to mention here that I am a retired Army Personnel having served the nation for 26 years and with the intention of building a residential house on my land I invested all my savings to purchase the same.
- 3. Due to the COVID-19 pandemic and the restrictions thereafter I could not visit my land as I reside at Shelpu Busty, Sitong under P.S. Kurseong and also that I am a senior citizen and with fear of contracting the virus I have been unable to look after my said land. On 24.01.2021 when I visited my said land first time after lockdown at around 10.30am I saw that the said Ranjit Singha along with his associates have engaged some labourers and masons with the intention of making some constructions on my said land. I protested and in doing so they left my land.
- 4. Today I again came from Sitong to visit my land along with my relative Sri Hemant Sha to make preparations for construction of boundary wall but I was astonished to see an incomplete structure built in the middle of my land and the said Ranjit Singha along with his associates were monitoring the said construction. I immediately prevented them from making further construction and I chased away the labour and mistry.
