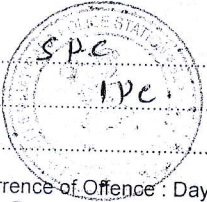

I, **DILRUBA SARKAR**, W/O- Humayun Mia@Lipton, age about 33 years presently residing at Saktigarh, P.S. – NJP, Dist- Jalpaiguri, do here by beg to inform you the following facts:-

1. That my marriage solemnised on **24-09-2020 with Humayun Mia@Lipton** as per Muslim Rites and custom by organizing ceremony at Haldibari, Purbapara, Ward No.- 1, P.O. & P.S. Haldibari, Dist.- Coochbehar and in the said marriage my parent gave dowry as per demand of in-laws family members i.e. gold jewellery of Rs. 4,00,000/- and cash of Rs.- 5,00,000/- and all household articles to the in laws family members and after marriage I am residing with my husband and other in-laws family members at **Beldangi, Tumbajote under P.S. – Matigara, Dist. - Darjeeling.**

2. That since from the date of my marriage my husband and in- laws family members namely **1) Humayun Mia@Lipton** (Husband), **2) Firoza Begam** (mother-in-law), **3) Raju Haque** (brother-in-law), **4) Mamta Begam** (sister – in law), wife of Palash Rahaman and **5) Serin Rahaman**, all are resident of **Beldangi, Tumbajote under P.S. – Matigara, Dist. - Darjeeling.**, started torture me both physically and mentally by demanding more dowry from me and force me to bring dowry from her parent and also say that her parent did not give sufficient dowry and demand more dowry from me and on refusal they all beated me by fist and blows and by kicks mercilessly by pulling my hair and **after that they confine me in a room and do not allow to talk with anyone and also not provide sufficient food to eat due to that I am suffering from starvation and I tolerated all the physical and mental torture with a hope that one day every thing will be alright and I would lead happy conjugal life.**

So, I therefore request you to kindly to investigate the matter and take necessary action against the adove named persons and save my life from their hands.
