Siliguri, Distt - Darjeeling do hereby inform you that, my marriage was solemnized nearly 20 (twenty) years back with Sri Tammay Roy S/o Lt. Manindra Nath Roy, presently residing at Ambika Nagar, P.S. Baleshwar Nagar (Near Mahananda High School), under Hindu rites & ritual, since after my marriage, my said husband started subjecting me for physical & mental cruelty, whenever I demanded maintenance amount from him to maintain my family.

On Dt. 01.03.2021 at about 05.00 pm, when I ~~was~~ reached near the house of Comrade Charu Majumdar, Mahanandapara, Ward No. 06 SMC, P.O. & P.S. Siliguri, at that time my said husband Tammay Roy, restrained me and started abusing me for filthy languages and when I protested, he started beating me brutally on the public road, and injured me grievously and therefore I called my son namely, Tushar Roy (10), and he reached there and immediately shifted to Siliguri Distt. Hospital.

Sir, my said husband is alcoholic person & spent all his income on alcohol and want to depend on my income, for that reason he used to follow me, wherever I used to go for my work, he used to follow me and subject me for physical & mental cruelty, even though he used to live separately from me and my 02 (two) children, since 1 1/2 years.

So, please take necessary action against my said husband, whose mobile No. is 7586094055.
