It is pertinent to mention here that my husband passed away in the year 2016 and after his demise I along with my mother in law continue to resides in the above mentioned address and after the demise of my mother in law the said subrata guha always tried to disposes me from my residential house and he also bring some miscreants to create nuisance and those miscreants abuse me with filthy languages in drunken condition and also threaten me with dire consequences.

That on 2.3.2021 at about 9.20 a.m. when I was clean the lawn of my house at that time the said subrata guha abused me with filthy languages and when I raised objection he outraged my modesty by tearing my wearing apparels and also physically abused me with fist and blow. It is not out of place to mention here that I have been treated at Siliguri district hospital.

Subrata Guha so that I can reside peacefully.
