Sir,

As directed, the Engineering Cell of SMC have inspected the site of the owners Smt. Priyanka Guha Rakshit, W/o Sri Achinta Guha, North Bharat Nagar, ward no. 24 of SMC, Siliguri on 11.11.2020. At the time of inspection it was seen that the owner of the house have newly constructed parking + 3 storied residential building. The team requested the owner to produce valid building plan of the said building but the owner had failed to show the same to the enquiry team.

On 12.11.2020 the owner submitted a building plan bearing no. 20122372 dt. 18.12.2015 in the name of Smt. Priyanka Guha Rakshit, W/o Sri Achinta Guha, North Bharat Nagar, ward no. 24 of SMC, Siliguri, Dist. Darjeeling. After receiving the documents official enquiry was done by the concerned Engineers of SMC (Building Section) namely Sri Brijit Aich, AE(Civil), Sri Rajarshi Sarkar (SAE, Civil), Sri Alope Kr. Sarkar, SAE(Civil) and Sri Arindam Chakraborty, (SAE, Civil) and it was found that this plan was not registered with this office at any time. Further, this plan appears to be forged. It can also be seen that signature and seal of Sri Ranjit Das, Consultant Civil Engineer is found in the body of the forged plan no. 20122372, dt. 18.12.2015. Therefore, in view of above and as opined by the OSD(Legal), SMC, I am directed to request you to lodge an FIR against the above mentioned owners, Civil Engineer for cheating and forgery of Govt. documents.
