I, Sri Biswajit Sharma, Son of Late Ajit Kumar Sharma, resident of 35, Lala Laj Pat Roy Road, Ashrampara, Ward No.14 of S.M.C. P.O. & P.S. Siliguri Dist. Darjeeling, PIN - 734001, lodge this written complaint to the effect that I alongwith my two sisters are the joint owner of a homestead land measuring 1866 Sq.ft. being Plot No.850, Khatian No.1734 in view of the order passed by the Ld. Civil Judge, Senior Division at Siliguri vide Title Suit No. O.C. (Partition) Suit No.41/2005 and we have been enjoying and possessing the aforesaid property in our khas and physical possession having right, title and interest therein. That on 07-03-2021 at about 11.00 A.M. when myself and my two sisters were trying to measure the land with the help of the Amin suddenly my two another brothers namely Sri Arup Sharma, Son of Late Ajit Kumar Sharma and Sri Indrajit Sharma, Son of Late Ajit Kumar Sharma, both are resident of 35, Lala Laj Pat Roy Road, Ashrampara, Ward No.14 of S.M.C. P.O. & P.S. Siliguri Dist. Darjeeling, PIN - 734001 and their family members obstructed us to measure our land and when we raised our objection against their illegal acts they became furious and started to assault me and my sisters with fist and blows and seeing the such situation when my wife try to rescue me from their hands they have also assaulted my wife and try to outrage the modesty of my wife due to such type of acts of two brothers and their families we became mentally puzzled for which some delay has been caused for lodging this complaint and still they are continuously threatening with dire consequences of our life and property.

I, therefore request you to investigate into the matter and please take strong legal action against them as per provision of law and oblige thereby.
