Sir,

I the undersigned like to inform you that today at about 08:30 PM, when I closed my shop situated opposite Gurudwara, Sewka Road, Siliguri and headed towards my car parked nearby, one person followed me steps by step. I dropped my bag containing Laptop and other documents in my car and opened the window of my car that person showed me a Pistol/Gun and tried to kill me. Thereafter I shouted loudly and local people came and that person went towards a bike bearing no. WB74AY1677 and there was one another person sitting in that bike but after hearing the noise, they both ran away leaving their bike and threw one loaded magazine with three ammunition and subsequently caught one person and handed over him to Police.

On interrogation of that person it has come to the knowledge that his name is Santosh Biswakarma the son of Anil Biswakarma addressed at Lakshy Cart Road, 27

S/O. Panitanki, Darjeeling. Also it is stated here that earlier on 20.07.2020 one person from mobile no. 9872161347 has called me and threatened me. Thereafter recently on 05.02.2021 the same bike has chased me and tried hitting me on Bardhaman Road fly over. Both the above incident has been intimated/ lodged with Khatpali TOP.

Therefore I request you good office to take a note of the above incident and do the needful as early as possible as per provision of law.
