With due respect I Karan Prasad, S/o Kamal Kishore Prasad resident of Gorung Basti want to inform you that today around 8:00pm when I was coming back from my work some anti-social elements named as: 1) Raju Sah, S/o Jay Shankar Sonar, 2) Sahab Paswan S/o Charan Paswan, 3) Rajesh Sani, 4) Shyam Yadav and many others suddenly attacked on me and snatched my cash salary amounting about Rs. 10,000/=, a gold chain and my wallet when I refuse to give them my money they started beating me with sharp weapons bamboo and also tried to stab me with their deadly weapons (Blade or some sharp weapons). After local people saw me in trouble they come to rescue me after seeing people coming they ran away with my belongings.

After some time they again come with more people and attacked my home with iron rods in their hands and also asking me for me in my locality, so I pray to you to take necessary action against them as they threatened my family that they will harm me more.
