I, Amit Singha Roy, Resident of Patikalany Road No. 1, Ward No. 47, Siliguri, would like to state you that I was brutally attacked by Ajay Sarkar, Resident of Panan Nagar, Ward No. 47, and 25 others. They were all intoxicated and attacked with iron rods and leather belts. During the attack they also snatched my gold chain and an amount of Rupers 2200/- in cash. All the incident happened in connec-
with previous incident the took place between my friend Ankur Das s/o. of Anup Das. and the same Ajay Sarkar when Ankur Das was brutally attacked by Ajay Sarkar and others.

An Complain was lodged by Ankur Das. on 24/07/21 against Ajay Sarkar, still one of Ajay Sarkar's friend Subham Das (Ph-96356-12326) called Ankur Das on 01/08/2021 at around 10.21 and threatened him to withdraw the complain else they will kill him. 15 mins later Ajay Sarkar arrived with 25 others and carried the violence. One of there security's number has been noted. (WB 74. BA-8108)

Therefore I request you to kindly take
action against Ajay Sarkar.
