Sub Lodging a F.I.R.

Respected Sir,

I, Sudhakar Paul, Son of Baidampaul residing at Hakimpura, Raja Ram Mohan Roy Road, Sikhar, would like to inform you that I am filing a complaint against Subrata Paul, Popi Paul, Sandip Paul, Sita Paul, Santa Paul and Susha Paul. The incident was taken place at Rabindra Nagar, Anupara, Sikhar at 10:30 pm on 10.08.2021 when I and my father went to above named place. The fact is that Sandip Paul who took money as amount of Rs 10,000/- (Ten thousand rupees) from my mother on 6.10.2020 and he promised to return the money to my mother within one month from the date he took. But after passing one month he did not return the money due to that me and my father went to his house on 4th December 2020 and at that time he promised to my father that he will pay the money in such money as installment way. On the beginning

he came to my house and pay Rs 2000 (Rupees two thousand) but after the very next month he did not come as well as inform us to give us the money. That time I went to his house and he refuse me to pay on the first instance then he told me that he will pay only Rs 500 (Rupees five hundred) and I agreed to receive that money with considering his financial condition or situation.

But Today when I and my father went to his house at 10:15 pm, because he came from his work after 10:00 pm. He refused to pay the amount after that I used to ask him publicly that when will you return the money, he replied with using strong language that he will not return the money and to also said whatever we can do, we can do. At the time of verbal interaction between me and him, his elder brother came along with his family members.

Came out from their house with using
slang language and when I refuse to talk
with them they were using physical force
towards us (me and my father) and slap on the
face of my mother. Later and that time
I used to defend myself as well as my father
they started beating us and snatch my car's
key which was received in front of the police
officer and when my mother after receiving
information present at that place, Popi Paul
wife of Subrata Paul tried to kill my mother
and broke my mother's gold bangles and snatches
one gold chain which was not expected from
her. Subrata Paul and his family members
giving us like threatened by saying he will cut
us and drag into earth.

In this instances, they broke my left hand's
finger and my parents were getting several
serious injuries on their bodies.

I also submit the X-ray report along with other

medical report of my parents. They, both of them
are in mental trauma.

At that time when the situation were turning
out of control, I informed the police station
and after receiving the information they came
to spot and after seeing the police they were
starting melodrama in front of the police and
tried to mislead the law.

I request you for proper investigation and
look after the matter and to kindly register the
complaint.

I shall be obliged if you take action against
them.
