In producing here with the accused person namely-Kanai Sahani (45) yrs, S/O Late Kishori Sahani of Maharaj colony, Near Shive Mandir, ward No-4, P.S.Siliguri, Dist. Darjeeling, along with seized (0) 15(Fifteen) bottles of Himalaya Gold 60 up Country spirit containing 300 ML in each bottle mentioning M.R.P of Rs- 50/- in each bottle i.e. total amount of Rs- 750/- (seven hundred Fifty) in which 01 (one) bottle taken as sample and marked as Exhibit "A-1" & 04 (four) Bottles of Officers Choice, each bottle 180 ML, M.R.P of RS 140/- Total RS 4/140= 560/-, 01 (one) bottle taken as sample and marked as Exhibit- "B-1"

I beg to report that today i.e. On 12-03-21 while performing special raid against illegal alcohol, at 18.15 hrs I received a source information that one person namely- Kanai Sahani (45) yrs, S/O Late Kishori Sahani of Maharaj colony, Near Shive Mandir, ward No-4, P.S.Siliguri, Dist. Darjeeling, is selling large alcohol in the house of the accd. Person at Maharaj colony, ward No-4, P.S.Siliguri, Dist. Darjeeling, Under Khalpara T.O.P without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I.C. Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for Maharaj colony, Siliguri to verify the veracity of the information vide Khalpara T.O.P CDE No -466/21 Dated- 12-03-21. After reaching Maharaj colony, Siliguri, Darjeeling at 20.00 hrs and as shown by the source I found the above noted person is selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search I could recover the above noted alcohol kept in the house of the accd. Person a gunny bag. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized the above noted recovered ED. Liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 20.15 hrs to 20.35 hrs On 12-03-21.

Under the above noted law may kindly be started against the above noted arrested accused person namely fact and circumstances, I therefore, pray that a specific case under proper section of Kanai Sahani (45) yrs S/O Late Kishori Sahani of Maharaj colony, Near Shive Mandir, ward No-4, P.S.Siliguri, Dist. Darjeeling for the possessing and selling alcohol illegally and arrange for its investigation.
