With due respect I, **SRI PARTHA SARATHI ROY**, Son of Sri Anil Roy, Resident of East Vivekananda Pally, Nazrul Sarani, P.O. Rabindra Sarani, Ward No. 38 of SMC, Siliguri, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to inform you that Smt. Pampa Roy, Daughter of Sri Harulal Ghosh is my legally married wife and our marriage was solemnized on 10.12.2010 according to Hindu Rites and Customs after observing all formalities of a Hindu Marriage. After my marriage, myself along with my wife have started to live and cohabited together as husband and wife at my aforesaid address and out of our lawful wedlock, one female child was born on 15.04.2012 whose name is Miss Antara Roy. Sir, after our marriage, we have passed our martial life happily and there was no problem either from my side or from the side of my wife and we have been passing our days peacefully with our minor daughter and presently, our minor daughter is studying in Class - III at Amarpati Lines Citizen Public School at Siliguri. It is to be mentioned here that my married sister Smt. Manashi Roy Chatterjee is the owner and occupier of a flat situated in the said compound where we have been residing having Flat No. C/2, though, my married sister is permanently residing at her matrimonial house at Shreerampur, Hooghly. Since last one month, the husband of my married sister namely Sri Ashis Chatterjee came at Siliguri and started to reside in their flat and since then, my wife in conspiracy with the husband of my married sister Sri Ashis Chatterjee, Son of Late Brojonath Chatterjee, have started to torture upon me both physically and mentally and my wife always created pressure upon me to extort money from me and on being refusal, she in conspiracy with

my brother-in-law Ashis Chatterjee have started tremendous torture upon me and also threatened me with dire consequences by saying that if I failed to fulfill her demand, she will not hesitate to implicate me in false criminal case and put me behind the Iron Bar for a considerable period. ^{on} Yesterday, i.e. 09.03.2021 at about 10.30 P.M., after completion of my daily work, when I entered in my flat, I found that my wife is in a compromising condition with said Ashis Chatterjee and seeing the said situation, when I made protest against their said illegal acts, they became furious and started to assault me physically and when I tried to restrain them, at that point of time, said Ashis Chatterjee snatched my golden chain (weighing about 39 grams approx) from my neck and took a sum of Rs. 3,000/- from my pocket forcefully and kept the same in his possession and thereafter, they also threatened to oust me from my own flat and also threatened me with dire consequences by saying that if I narrate the said facts to any authority or any person, they will lodge false complaint against me and put me behind the Iron Bar and if required, they will not hesitate to ruin my life and property. Due to the assault by said Ashis Chatterjee and my wife, I have received severe injury on my person and treated at Siliguri District Hospital.

I, therefore, request you to kindly investigate into the matter properly and please take strong legal steps against them as per the provision of law and obliged thereby.
