- (1) 04 (Four) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/-
- (2) 16 (Sixteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 300 ML, MRP Rs.50/- (Total 7.2 Litre & amount 1200/-)

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Bappa Saha (40) S/O Late Manoranjan Saha of Sukanta Nager Near Janakalyan Ashram PO Rabindra Sarani PS Bhaktinager Dist Jalpaiguri to the effect that, on 15.03.2021 evening as per order of O/C Ashighar OP I along with ASI Sumit Baran Nath ,C/ 134 Ginen Basumata and CV/603 Arun Roy , all are of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigarh OP in course of which I received information from my source that one Bappa Saha stored a huge numbers of bottles liquor inside his house at Sukanta Nager-Near Janakalyan Ashram and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Sukanta Nager Near Janakalyan Ashram area to verify the veracity of information. On the way I called two local person namely (1) Sujit Roy (35) S/O Sachin Roy of Naresh More Telipara PS Bhaktinager Dist Jalpaiguri and (2) Dipankar Saha (31) S/O Sankar Saha of Niranjan Nager ward no 36 PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Sukanta Nager near Janakalyan Ashram area as indicated by my source I held raid at the house of Bappa Saha at Sukanta Nager near Janakalyan Ashram. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 20.30 hrs and 20.55 hrs on 15.03.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons namely Bappa Saha (40) S/O Late Manoranjan Saha of Sukanta Nager Near Janakalyan Ashram PO Rabindra Sarani PS Bhaktinager Dist Jalpaiguri and arrange for its investigation.
