Sir,

In producing here with the accused person namely-Upendar Sahani (22) yrs, S/O-Sri. Suresh Sahani of Maharaj colony, Near Kochara Math, ward No-4, P.S.Siliguri, Dist. Darjeeling, along with seized (i) 20 (Twenty) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.L.P of Rs- 100/- in each bottle i.e. total amount of Rs-2000/- (Two thousand) in which 01 (one) bottle taken as sample and marked as Exhibit "A-1"

I beg to report that today i.e. On 14-03-21 while performing special raid against illegal alcohol, at 18.45 hrs I received a source information that two persons namely- Upendar Sahani (22) yrs, S/O-Sri. Suresh Sahani of Maharaj colony, Near Kochara Math, ward No-4, P.S.Siliguri, Dist. Darjeeling, and Sri Umesh Singh s/o Lt. Bindeswar Singh of Gowalapatty, Ward No-IV PS Siliguri Dist. Darjeeling are selling huge alcohol in their house of the accid. Persons at Maharaj colony, ward No-4, P.S.Siliguri, Dist. Darjeeling, Under Khalpara TOP without any valid license and documents in higher price than the actual value for their illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S. over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for Maharaj colony, Siliguri to verify the veracity of the information vide Khalpara TOP/GDE No -548/21 Dated- 14-03-21. After reaching Maharaj colony, Siliguri, Darjeeling at 19.15 hrs and as shown by the source, I found the above noted persons are selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him and Umesh Singh s/o Lt. Bindeswar Singh of Gowalapatty, Ward No-IV PS Siliguri Dist. Darjeeling fled away from the spot. On being asked the arrested accused disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept in the house of the accid. Person a gunny bag. During interrogation he admitted that he along with Umesh Singh selling alcohol for their wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted persons are selling alcohol illegally since long. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S 41 Cr.P.C. under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 19.45 hrs to 20.35 hrs On 14-03-21.

Under the circumstances own specific case may kindly be started against the arrested accused person namely Upendar Sahani (22) yrs, S/O-Sri. Suresh Sahani of Maharaj colony, Near Kochara Math, ward No-4, P.S.Siliguri, Dist. Darjeeling and Umesh Singh s/o Lt. Bindeswar Singh of Gowalapatty, Ward No-IV PS Siliguri Dist. Darjeeling for the possessing and selling alcohol illegally and arrange for its investigation.
