Sir,

With due respect I, Subrata Roy, Deputy Ranger/Forester, Parks & Gardens (North) Division, Siliguri beg to lodge the complaint against Shri Kanak Kumar Das, PDL of the mentioned Division under Forest Directorate.

Today i.e. on 15.03.2021 while on official duty in Division office, Shri Kanak Kumar Das, PDL assaulted me without any provocation advancing menacingly towards me. He tried to box me on my face which I somehow blocked and even attempted to kick me which was prevented by my colleagues of my office. Taking me unaware he caught hold of my right hand and twisted the arm to the manner incurring substantial pain. I was actually on my way to deposit Government Revenue of Rs.61,460/- which he tried to snatch. I managed to save the same and move out of the office. While moving out he followed me hard for his evil intent. I am submitting herewith the proof of my medical examination for your kind cognizance. The entire work atmosphere had been vitiated and all the staff members are petrified. Earlier he resorted to such ignominious practices. On 13.09.2018 he threatened Contractual Computer Operators of Minor Forest Produce Division of dire consequences and even tried to assault Subrata Paul, the then UDC of Monitoring (North) Division. A General Diary was lodged on the said date with your kind concern. A copy of the same is attached herewith for needful reference.

Under the circumstances I pray before your kind to take note of the fact. The person concerned may resort to such reprehensible measures which are likely to incur irreparable damage. I therefore solicit appropriate measure from your end so that such possibilities can be avoided.

For this I am in duty bound shall ever pray.
